## TAX TALK

A PUBLIC SERVICE OF H&R BLOCK

**Q.** I am employed as a commission salesman and would like to deduct in home expenses as employment expenses on my tax return. I heard that the rules for claiming these expenses are quite strict and am wondering if I will be able to claim them?

**A.** It depends on how your home office is used. In order for you to claim the expenses, the home office must be either your principal place of employment, or be used exclusively for the purpose of earning income and be used on a regular and continuous basis for meeting customers for business reasons. In addition, you must have a completed Form T2200, certified by your employer, to make the claim.

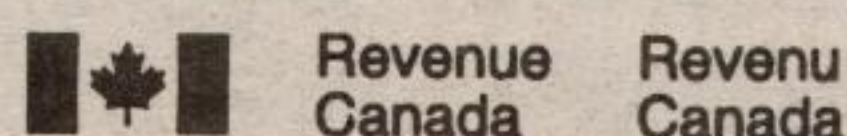
