### TAX TALK

A PUBLIC SERVICE OF H&R BLOCK

**Q.** My employment contract requires that I pay for certain employment expenses for which I am not reimbursed. I know that I can deduct them on my tax return but was wondering if I can register for the GST in order to recover the GST I paid on these expenses?

**A.** No. As an employee, you may not be a GST registrant. However, you can still recover the GST paid on your qualifying employment expenses by claiming a GST rebate on your income tax return. The rebate is claimed on line 457 by filling out Form GST370. In the taxation year that you actually receive the rebate, you must declare it as income, except any portion relating to the purchase of a vehicle or musical instrument, which is used to reduce the capital cost of the item instead.
