Event held to pay trustees' legal bills

Complaint puts school's donation on hold

parent's complaint has put a school council's L efforts to raise money for Halton trustees on hold.

The Robert Little Public School council held a hot dog sale April 18 to raise money to help pay the legal costs of five trustees who were brought up on conflict of interest charges by the Burlington Taxpayers Coalition. The charges were withdrawn in March but the trustees, including Acton/Esquesing trustee Ethel Gardiner, were left with legal bills. At the time, Gardiner estimated her expenses at between \$4,000 and \$5,000.

"We felt it wasn't fair that the trustees (expenses) were not covered by the board because as employees they should be," said

Julia Roehrig, the school council chair. "We thought we could help out."

Roehrig said the sale, which raised \$305.16, had the best participation of any school fundraiser. She had been contacted by two other schools, regarding organizing similar events. However, the donation to the trust fund set up for the trustees is now being held until the council decides what to do with the money at its next meeting on May 6.

Robert Little principal Don Warren said the school did not receive any complaints before the sale. He said the first indication of someone not agreeing with the sale was when a parent hand delivered a letter to the school during the sale. Warren said the basis of the complaint was that the trustees' situation "was a private matter."

Roehrig said she heard of one,


parent, though not directly, who said her child would not be purchasing a hot dog because she didn't believe the fund-raiser was appropriate. She thought anyone who didn't approve would act in a similar fashion.

A similar event planned at McKenzie-Smith Bennett, organized by a parents' group, has been cancelled. School council chair Joanne Stevenson said "the board felt there was a legitimate concern that the students would be involved in what could be perceived as a political issue."

Gardiner said she appreciated the school council's effort but didn't want the sale to create problems.

"It came about through the good intentions of the community," Gardiner said. "Obviously, a parent disagrees and I hope they can work it out."





TAX TALK A PUBLIC SERVICE OF H&R BLOCK

Q. Starting in July, my Old Age Security cheque was almost \$100 smaller than before. Why is this, and what can I do about it?

A. In July, the government began deducting the OAS clawback from your monthly OAS cheques.

The amount deducted is based on your 1995 clawback. For example, if you had to repay \$1,200 of your OAS is 1995, the government began deducting 1/12 of that amount from your monthly cheques in July. When you file your 1996 tax return, you will calculate your actual OAS clawback based on your 1996 income. If too much was deducted, you will get it back; if too little, you will have to pay it when you file your 1996 return.

There is no way to avoid the clawback deduction other than to reduce your net income below the clawback threshold, currently set at \$53,215. Therefore you should take advantage of as many tax deductions as possible.
