Finance department escapes flood of tax bill complaints

Talton Hills finance department received Afewer than expected calls about the 1998 tax bills.

With all the confusion surrounding tax bills this year reassessment, town and region tax increases and provincial downloading— the town's finance

department had been expecting numerous calls, many in the complaint category.

"Given the experience of the City of Burlington and the Town of Oakville, it had been our fear that the finance department might experience some difficulty in responding to the customer inquiries with existing staff resources," said town treasurer Andrew Koopmans in a report to town council.

Instead, the number of telephone calls and counter inquiries were only slightly higher than normal— although the time taken to answer everyone's questions took longer.

"Understandably, from time to time, staff felt somewhat overwhelmed and exasperated by the levels of taxpayer confusion which resulted from the multitude of 1998 tax changes," said Koopmans.

"It is hoped that this type of confusion will diminish substantially in 1999 as our taxpayers adjust to the new system of taxation and assessment in Ontario."

One most frequently asked question concerned education taxes, with many property owners being convinced that they were no longer responsible for education taxes.

The provincial government, which had inititially stated that

they would pay all the education taxes, changed their minds early in 1998 and agreed to pick up only half (province-wide). In Halton that worked out to a 42 per cent reduction in education taxes for property owners, Koopmans said.

Halton Hills Councillor Ron Chatten said he wants to see a future council resolution passed to remove all education tax dollars from the residential portion of the property tax bill.




