At a recent open house, hosted by the town's Millennium Committee, more than 30 residents attended to find out more about three grants offered by the federal government. Events already being planned include the Acton High School 2000 reunion, the Glen Williams New

Year's Eve 2000 celebration : and the Remembrance Park The Future Begins with You! between \$500 to \$100,000. rejuvenation project.

"This was a good start to something we think will bring the community closer together as we travel into the new millennium," said Stephen Onoprijenko, a Recreation and Parks Department co-op student who has volunteered to work on the town's millennium committee.

The committee is encouraging residents, organizations and businesses to mark the millennium in meaningful and creative ways such as family reunions, baseball tournaments, art festivals or projects that involve the whole community, he said.

 EcoAction 2000: For projects that protect or enhance the environment in the community. If at least 50 per cent of the funding is from a sponsor other than the federal government, this grant will contribute

Deadlines: Feb. 1, 1999 and Oct. 1, 1999. · Millennium Arts Fund: Funding for professional artists and professional arts organizations in all artistic disciplines to create works that will enhance collections, repertoires and public places. Up to \$250,000 for artistic, production, and promotional costs. Deadlines: Dec. 31 and Sept. 1, 1999.

Letters of support from the mayor are available to accompany all grant requests.






