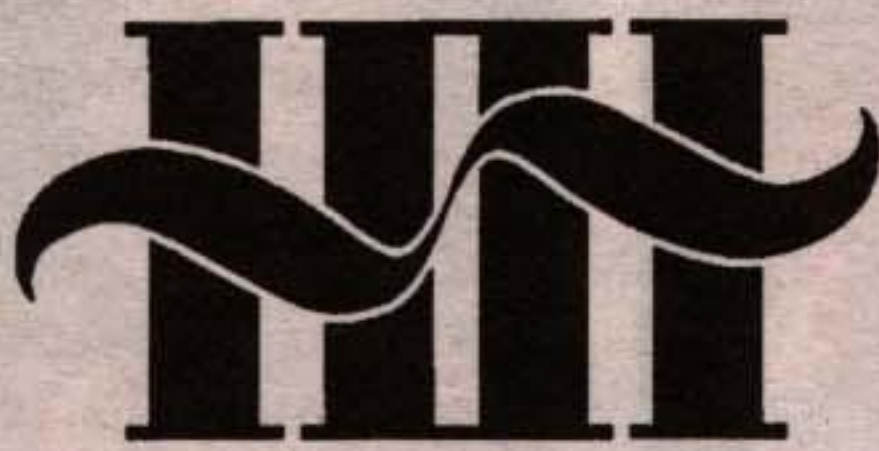


Preliminary hearing date set

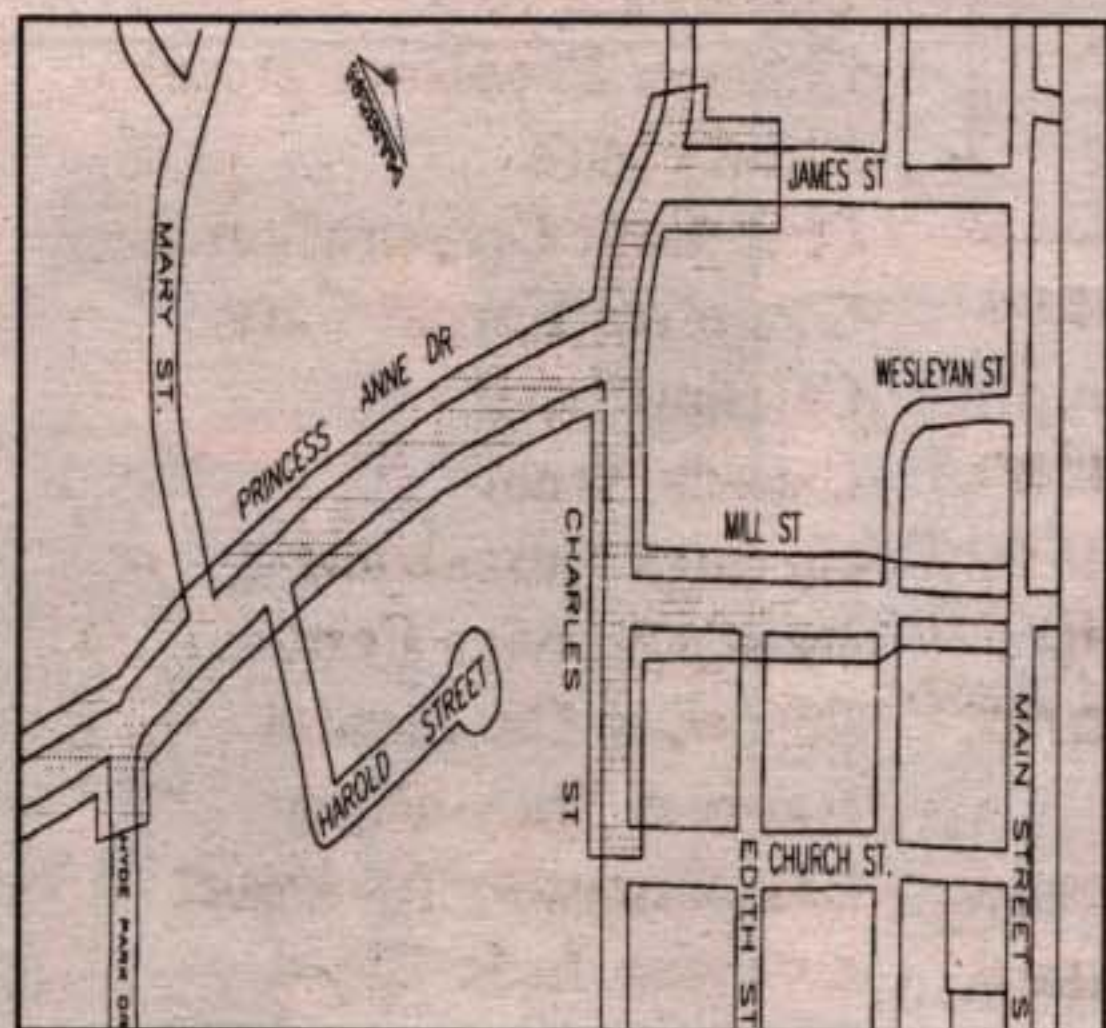

Agricultural Society to get new building on arena site

Varanelli said he would not be satisfied with a council motion to support "in principle" a new building on the arena site. "It took us six and half years to get to this point. If we leave this only as an agreement in principle—it goes back to staff, it goes back to committee, it goes back to park master plans, we'll be talking about this for another six and half years. And that's why we were so specific in terms of our presentation. Unless we get those kinds of specifics in a motion, we haven't achieved anything here tonight and anything more general would not be acceptable."

After a three hour debate councillors unanimously approved recommendations which mirrored the AAS's request. They included:

- AAS's proposal to build and operate a building in Prospect Park be granted with its location consistent with the upcoming park master plan.
- AAS will be given a lease to operate a building up to 15,000 sq. ft. (that's slightly larger than the current ice pad surface).
- Town of Halton Hills waives all permit fees, associated with the construction, within its jurisdiction.
- Town of Halton Hills expedites the building process where possible.
- Acton Agricultural Society pays for the cost of the construction of the building including related services, maintenance, insurance and ongoing expenses.

MPP says he got sides 'talking' about arena

Halton North MPP Ted Chudleigh says he became involved in the Acton arena issue after concerns were raised to him by local residents.

Last week Chudleigh met with the Agricultural Society, Heritage Acton and the town and said he got them talking.

"I'm not sure council had all the information at its disposal when it made its decision," Chudleigh said Friday.

The MPP said the Acton Agricultural Society has a perpetual lease to use the arena and added council received legal advice that was no longer in effect. Chudleigh said discussions with the Acton Agricultural Society revealed their legal opinion wasn't the same as the town's and he didn't believe the town had the Agricultural Society's legal opinion on the lease when it made its decision.

Halton Hills Mayor Marilyn Serjeantson said the town and Society had been talking all along

designed satisfactory to both the town and AAS.

- AAS must release the town from all obligations under the 1962 agreement.
- AAS must enter a maintenance agreement regarding the maintenance, use and scheduling of the facility to ensure compatibility with the park.
- AAS negotiate with the town for the town's use of the building at no cost for community-based activities on an occasional basis.

However a recommendation, to give the AAS the remaining funds (up to a maximum of \$20,000) out the demolition budget, was hotly debated.

Georgetown Regional Councillor John Day said the decision to give the AAS money was premature and should be dealt with during the budget process. His effort to have it deferred failed.

Acton Regional Councillor Rick Bonnette said the \$20,000 will be coming out of the unspent demolition budget and means no new raised taxes while Ward 2 Councillor Kevin Kuiack called it an investment which the town will recoup in a couple years.

Voting for the \$20,000 payment were Councillors Norm Elliott, Bonnette, Mayor Serjeantson, Clark Somerville, Kuiack, and Jane Fogal. Voting against were Councillors Bob Inglis, Moya Johnson, Kathy Gastle, Day, and Ron Chatten.

AAS now intends to begin fund-raising for the \$300,000 building.

and that "we were certainly aware of the agreements between the town and agricultural society."

Chudleigh said he also met with the Minister of Citizenship, Culture and Recreation, and that the province had a lien on the arena because the government had given the town more than \$80,000 over time in capital costs to the arena.

He said the town needs the minister's permission to tear down the building or has to make restitution. He said if everything goes well, "I'll do what I can to get them to drop that lien."

He said he didn't think the town was aware of the lien when it made its decision on the arena.

"We were aware there had been grants," said Serjeantson Tuesday. "We were not aware the province would come in and say, 'give us back the grants we gave you 20 years ago', to keep the arena running."
