

#### NOTICE OF A PUBLIC MEETING WARD 2 / WORDEN VIEW FIFTH LINE - HWY. 7


General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed amendment to the Official Plan. The application proposes to allow the development of six rural estate residential lots adjacent to an existing rural estate plan of subdivision. The proposed development is also the subject of an application to amend the Region of Halton Official Plan (File No. RQ13A).

The subject property is bounded by Hwy. 7 to the north, Fifth Line to the west and Worden View to the south.

The public is invited to attend the meeting to ask questions and provide comments. If you wish to be notified of the adoption of the proposed official plan amendment, you must make a written request to the Town of Halton Hills, P.O. Box 128, Halton Hills ON L7G 5G2. If a person or public body that files an appeal of a decision of the Town of Halton Hills in respect of the proposed Official Plan Amendment does not make oral submissions at the public meeting, or written submissions, to the Town of Halton Hills before the proposed official plan amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.


#### CONSTRUCTION NOTICES


