Trail plans get off to good start

The trails meeting held on March 31 was a great success. We had about ■ 70 members of the public participate in our trails master plan workshop.

The town's vision is to provide various recreational opportunities for all our citizens. One of the town's millennium projects is to begin construction of part of our trails system this year, starting at the Willow Park Ecology Centre.

As stated in last month's column, the town is in the position to purchase the Hungry Hollow ravine. However, I must emphasize that there are the outstanding subdivision applications, HHVHI, and Silvercreek Estates that have been referred to the Ontario Municipal Board. The public meeting for the subdivision applications is scheduled for Monday, April 26 at 7 p.m. at the Georgetown District High School. The site walk of the area will take place very soon after the public meeting. Council will receive the final report in early May.

The Town of Halton Hills Planning Department made a presentation to the Halton District School Board on the need for schools in the Georgetown area. The Georgetown South school site application has been moved from a Priority 3, to a

Papke noted that besides mould cleanup, work on anchor tie-downs, gable grates and adherence to building codes had to be considered.

He said portable cleanup costs in Oakville were higher because of the town's stricter inspection requirements. But this was not a major factor in the increased overall cost, Papke added.

The education director said the extra cost will be covered through capital reserves and

operating budget. "It will all be paid out by the next budget," said Papke.

The \$4.1 million will be paid out from facility/school renewal programs in budgets from the 1998 short year (\$480,000),

1998/99 (\$800,000),1999/2000 (\$2.14 million) and through board reserves for other capital (\$700,000).




