#### Stubborn fire

■ Halton Hills firefighters spent nearly four hours fighting a grass fire that extended across approximately 40 acres on the Sixth Line north of 22 Sideroad Thursday afternoon.

## Regional taxes to fall by 2 per cent

There will be some relief for Halton residents this year as they shell out about \$31 less in regional levies.

That's a two per cent decrease over last year.

The savings would have been higher without factoring in a previously passed regional utility rate budget, which increased by one per cent, or \$4 a year.

When it comes to property taxes alone, a newly unveiled preliminary budget showed the region has trimmed Halton property taxes by 3.1 per cent this year.

That boils down to \$34 for the average

taxpayer with a home assessed at \$185,000.

The cut goes beyond a regional council directive for staff to hold the line in 1999 taxes, or, at worst, only increase them by the inflation level.

"What we've provided you with is a budget that goes far beyond that direction," said Halton chief administrative officer Brent Marshall. "This 3.1 per cent reduction should be a good news story to our taxpayers."

These figures do not include the effect of municipal budgets, which have not all been completed.

Though the news may seem good, there are still some uncertainties, warned Joe Rinaldo, the region's finance commissioner.

"There's a number of services (for which) we still don't know what the impacts are," he said. "GO Transit is an example of that."

Varying reports give GO expansion an eventual price tag of between \$50 million and \$200 million. Currently, Halton is expected to shell out for 10 per cent of GO costs.


That percentage, which is based on total tax assessment, could rise with Halton's growth.
