We got lucky

Despite itself, justice was done in a Toronto courtroom last week when, 13 years after the fact, Francis Carl Roy was convicted of the first-degree murder of 11-year-old Alison Parrott.

We say despite itself because almost every facet of the Parrott case spoke volumes of the problems in our justice system. Problems that allowed Roy the opportunity to kill Parrott and then almost avoid conviction.

This case, which paralyzed Toronto in the summer of 1986 when the youngster was lured to a phony photo shoot by an unknown man, raised several disturbing questions:

• Why was Roy's five-year sentence for a 1980 rape reduced in half by the Ontario Court of Appeal?

• Why was a man convicted of two rapes (in 1979 and 1982) on day parole by 1985?

• Why was the jury in the Parrott case given an edited history of Roy's criminal past with the rapes excluded? The judge ruled the evidence too prejudicial but certainly this information would go towards determining Roy's character. Furthermore, should it not be left to the jury to separate their emotions from reasoned thought and not the court to offer a sanitized version of a suspected sex offender's criminal past?

Francis Roy is now off to prison (pending appeal of course) and we can boast about how our justice system has put a killer behind bars.

Yes indeed, the system worked. Barely.

The existing commercial facilities in Georgetown experience overcrowding and parking problems, causing some residents to shop outside the community.

With respect to comments made about a municipal arena or pool being built somewhere in Georgetown, it is my strong belief that people here would be thrilled to get a new arena and pool anywhere in Georgetown, the location is secondary.

In their fight against the rezoning of Georgetown South industrial lands, the residents of Georgetown and surrounding area have shown a unity of purpose and a passion to preserve this small town and its values. I have certainly not received the impression that any one neighborhood wishes to place its needs above another. People are focusing their energy on the big picture—how to make a better place to live for everyone!
