Provincial changes good for Halton

Then the provincial government shifted responsibility for a number of programs to the Region of Halton, cut grants and created pooling across the Greater Toronto Area (GTA), regional council was concerned how these changes would affect our residents. We voiced our concerns with the province and they listened.

On March 23, Finance Minister Ernie Eves released updated budget information to all municipalities across Ontario. Related to this were several announcements regarding cost-sharing a number of social services and health programs.

Regional staff reviewed what all this information means for Halton, but most importantly, for regional taxpayers. In some cases, it means more responsibilities for the region, but financially, the impacts are positive.

This week, regional council will consider the 1999 budget. As a result of the hard work of regional staff and these recent provincial announcements, staff are able to recommend a 3.1 per cent decrease in regional taxes over last year.


Eves' announcement did not have the same positive effect on the Town of Halton Hills taxes— instead taxes will increase slightly. However, we are very conscious that there is only one taxpayer in Halton and I am pleased that the proposed regional tax decrease is sufficient to offset the majority of the impact of the province's announcements on the Town of Halton Hills. The net result on Halton Hills taxpayers is a combined regional and town tax increase of only .1 per cent or \$2 per household.

The province also responded positively to our concerns in two other areas: the role of the Greater Toronto Services Board (GTSB) and council's request for the direct election of the regional chairman.




The GTSB provides a forum within which GTA municipalities can work together to promote co-ordination of interregional services within the GTA. Halton regional council has been quite clear that it does not support the creation of another level of government. Municipal Affairs Minister Al Leach assured me the GTSB will not be another level of government. It has no service delivery responsibilities other than overseeing the operation of GO Transit, has no direct taxing authority and will not require a large bureaucracy.

Leach has also written in response to regional council's request that legislation be changed to allow for the direct election of the regional chairman, by the people of Halton. Currently the 20 regional councillors elect the regional chairman. Leach indicated that he intends to recommend the direct election of the regional chairman and will look for an opportunity to introduce the required legislation for this to occur in time for the November 2000 municipal election.

There have been a lot of changes over the past few months and the region is pleased with the province's response to our concerns regarding these changes. We have a long road ahead of us, one the region is prepared to tread for the benefit of our residents.


