## MADD donates van to police


Halton Regional Police are proud owners of a new RIDE van thanks to MADD (Mothers Against Drunk Driving) Halton.

• My husband and I recently sold our house. Now I have • changed my mind and don't want to sell. Can I get out of the deal?


• I assume by your question that you have entered into an Agreement of Purchase and Sale. An Agreement of Purchase and Sale is a legally binding contract and the contract can be enforced unless there are conditions in the contract which allow you to be released. These conditions are usually very specific and you must act in good faith. If you breach your obligations, the contract may be enforced against you and/or you could be sued for damages.


Even if the proposed purchasers of your house agree to release you from the Agreement of Purchase and Sale, you may have obligations to the realtor who negotiated the deal. When you listed your house for sale you probably entered into a listing agreement which set out the circumstances when commissions would be payable. This may mean that you owe commissions to the realtor.

Entering into an agreement to sell your home is a legally binding contract. Before taking any action, you should review the Agreement of Purchaser and Sale and your listing agreement with a lawyer who can explain your rights and obligations.

O Does laser eye surgery really eliminate the need for glasses or contact lenses?

A This type of eye surgery is called refractive laser surgery. It's intent to reduce the dependence on glasses or contact lenses. In many cases that I have dealt with, the eyes have been completely corrected. In some cases the optical error has not been completely eliminated and glasses are still used occasionally. In all cases there has been a tremendous reduction in the overall correction (myopia, hyperopia and astigmatism) and the people involved are very satisfied with the results. For those who would normally require bifocals or reading glasses, the need for a reading correction is still there. Younger people will get to that point eventually. Some people who are near sighted (myopic) elect to leave one eye under corrected so that this eye will focus up close. This approach is called monovision. So . . . the promise of throwing away your glasses or contacts comes with a big maybe. This is surgery. There are risks and occasionally complications and unsatisfactory results.

The two main surgical techniques used to correct vision are, PRK (photorefractive keratectomy) and LASIK (laser-in-situ keratomileusis). Both procedures have excellent results but LASIK is gaining more popularity. Detailed descriptions of these procedures can be found at T.L.C.'s website

(www.lzr.com) or at your Optometrist's office.

Optometrists will often co-manage the whole laser process with the laser centre and the surgeon performing the surgery. This is what I do. We perform the pre-operative examination/evaluation and give our advice. Once the surgery is performed we do all of the past-operative follow up and evaluations, starting at day one and for the following year. Refractive laser surgery is not for everyone and the best place to start asking questions in in your Optometrist's

A \*Children can definitely benefit from counseling. Nowadays, children are confronted with many challenging situations such as family restructuring due to divorce or remarriage, various forms of abuse or trauma, difficulties with social skills, etc. Children often don't have the ability to understand or verbalize their feelings. Not only do children learn to put their feelings out, they also learn ways to better cope, and when possible to create solutions to resolve their problems. From a child's perspective, art therapy is often a fun way to talk about the tough issues that are weighing on their minds.

I have had sore feet for the past several U:months. Someone suggested it would be due to overweight. Is this true?

.Have you gained some weight over the winter? According to Walking Magazine, April 1996, one study reports a definite relationship between weight gain and foot pain. The study followed 580 women for a five year period. The findings were that overweight women suffered from almost 3 times more heel pain and developed twice as much tondonitis as women within normal weight parameters.

Overweight women were also found to have a 50% higher rate of fracture and ankle sprains. So give your feet a rest, and keep your weight under control with a combination of healthy eating and regular exercise.
