\$200,000 shows town's committment to new buildings

Recreational facilities money added to budget

Talton Hills budget committee, at last Thursday's capital budget meeting, included \$200,000 in this year's capital budget to fund preliminary engineering and architect selection for new recreational facilities.

This money is not guaranteed until final approval of the capital budget next month. As well, the town council needs to actually approve the build-

ing of new facilities— and that may, or may not, happen when a staff report is presented to a council meeting next month.

The inclusion of the \$200,000 will go a long way in showing the community the town is committed to building a new recreational facilities, said manager of facilities Paul Stover.

A recent consultant's report identified the twinning of

Gordon Alcott Arena for a second ice surface and new pool facilities as the town's number one recreational priorities. The May staff report will address this report as well as funding and location.

Mayor Marilyn Serjeantson supported the \$200,000 inclusion saying the public has told council that facilities are needed, and "we should just get on with it as it not getting any cheaper."

Facility Strategy Study committee chair Councillor Jane Fogal said "money needs to be on the table" to show the people "we're serious."

Acton Councillor Norm Elliott warned that new facilities are not necessarily uppermost in all taxpayers' minds—some people are more concerned about roads in front of their homes. He added Acton residents were watching the new facility issue closely.


