NOTICE OF THE PASSING OF AN EDUCATION DEVELOPMENT CHARGES BY-LAW BY THE HALTON CATHOLIC DISTRICT SCHOOL BOARD

TAKE NOTICE that the Halton Catholic District School Board passed an Education Development Charges By-Law on the 18th day of August, 1999, under section 257.54 of the Education Act, 1997.

AND TAKE NOTICE that any person or organization may appeal the By-Law to the Ontario Municipal Board under section 257.65 of the Act by filing with the Secretary of the Halton Catholic District School Board on or before the 27th day of September, 1999, a notice of appeal setting out the objection to the By-Law and the reasons supporting the objection.

The By-Law comes into force on August 31, 1999. The education development charges imposed by the By-law are as follows:

- \$689.00 per dwelling unit in regard to residential development
- \$0.15 per square foot of gross floor area in regard to non-residential development

The education development charges are imposed on all development of lands in the Region of Halton. Accordingly, a key map showing the location of the lands subject to the By-Law is not provided as part of this notice.

A copy of the complete By-law is available for examination in the offices of the Board located at 802 Drury Lane, Burlington, Ontario, during regular office hours.

Notice of a proposed by-law amending the education development charge by-law or the passage of such an amending by-law is not required to be given to any person or organization, other than to certain clerks of municipalities or secretaries of school boards, unless the person or organization gives the secretary of the Board a written request for notice or any amendments to the education development charge by-law and has provided a return address.
