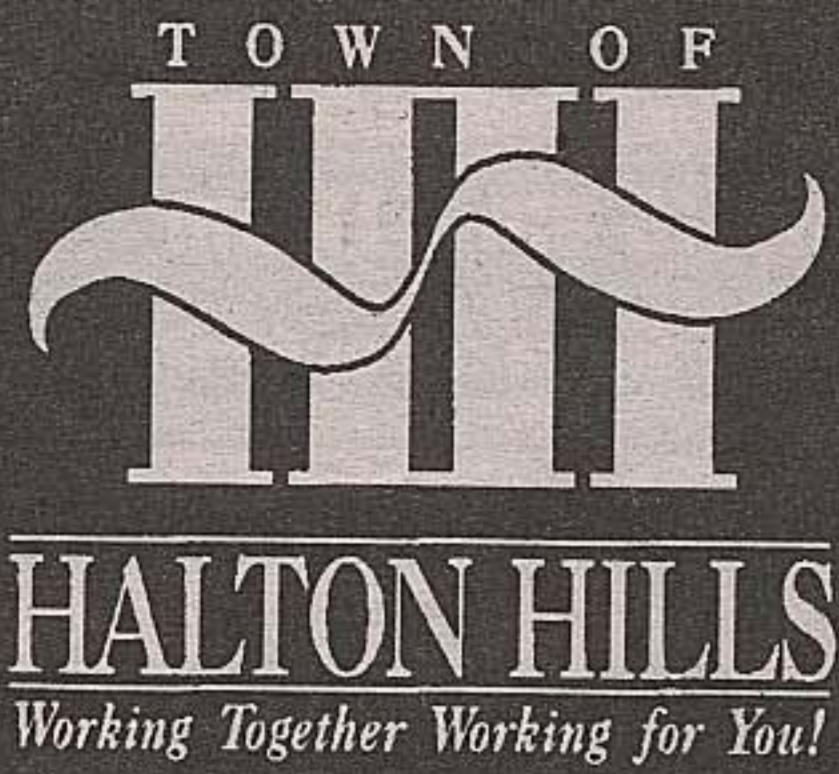


*Police seek public's help in catching break-in suspects*

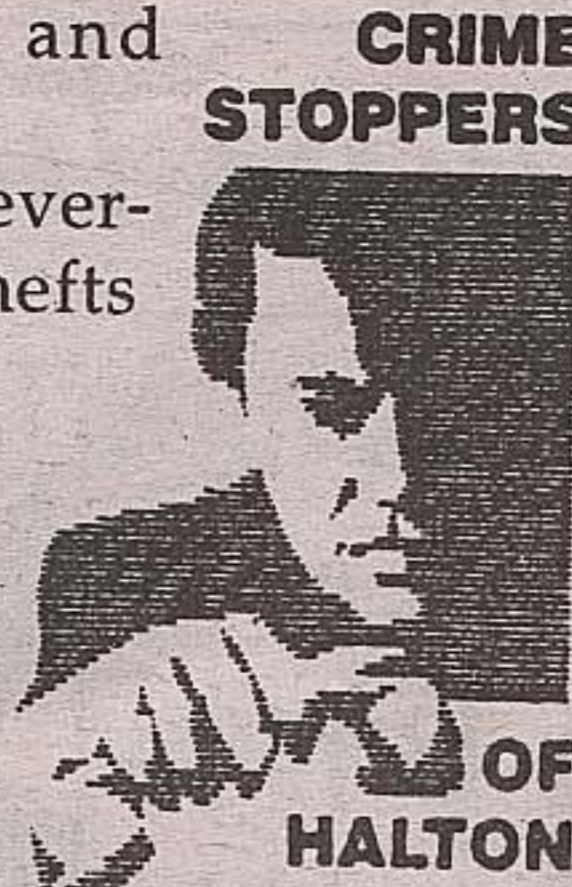
