An important date to remember is December 12. The Ladies

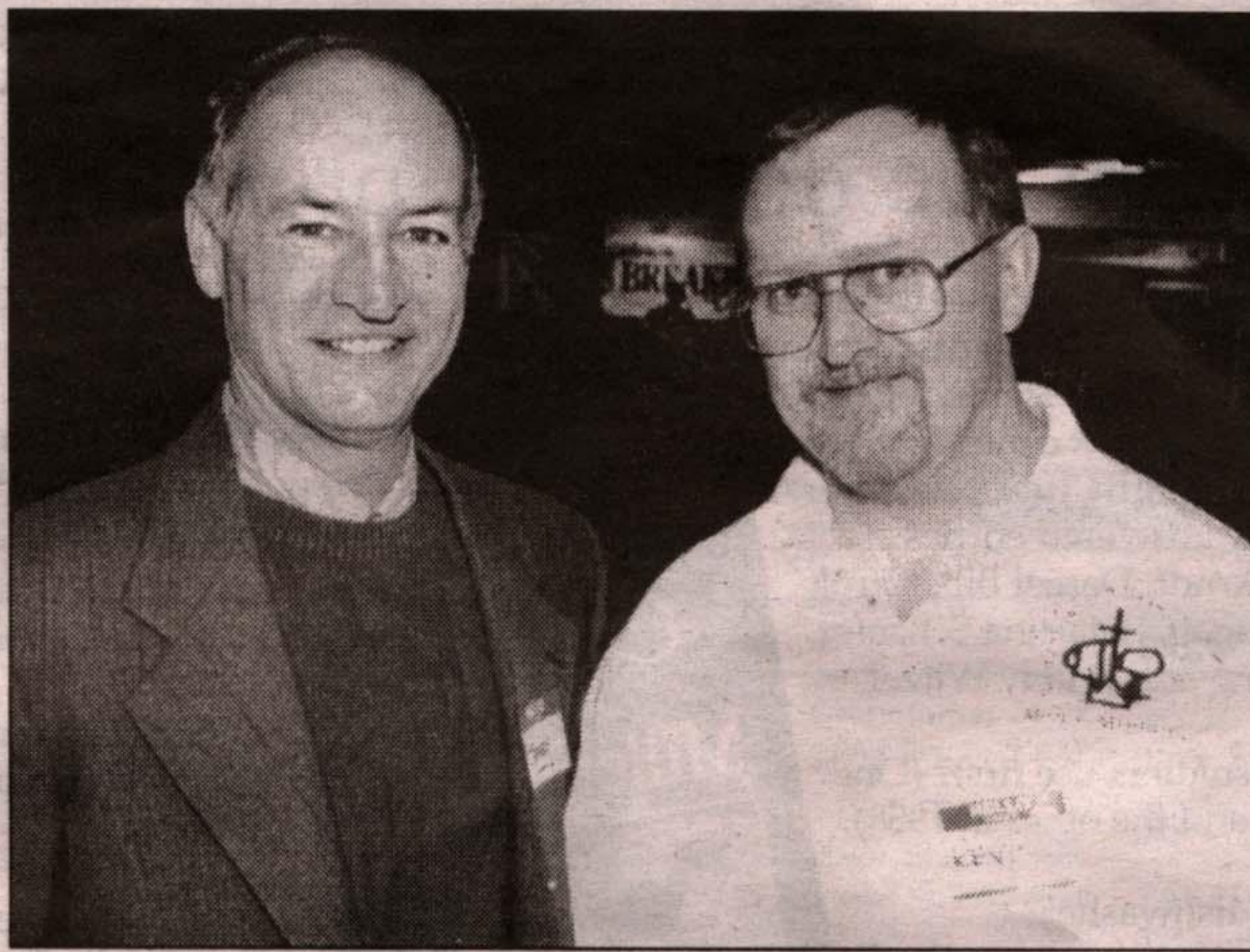

Expropriations Act, R.S.O. 1990, c. E.26 NOTICE OF APPLICATION FOR APPROVAL TO EXPROPRIATE LAND
