Region well test concerns Sixth Line-area residents

esidents who live near a test well on Sixth Line that's currently being considered to provide water for new development in Georgetown, are worried it will impact their water supplies.

Halton Region plans to pump about five million gallons of water from the Sixth Line well between 10 and 15 Sideroads during a two-week test to see if it would be a good source of additional water for Georgetown.

"We're concerned what will happen to our water," said Doreen Wickson. "We want to maintain the quality and quantity of water we have now."

The residents who live near the test well are concerned about both the test and the long-term impacts if the well is used as a municipal water source.

"What will they do if we do lose our water, or if it's diminished?" asked Wickson, who has lived on the Sixth Line for nearly 20 years and has never experienced water problems.

Sixth Line resident, Phil Hansen, is also concerned. He said a report done after the region conducted a test on the well in 1991 implied the water level in his well would be lowered if the municipal well was put into service.

"Water is a scarce commodity," he said, adding his well now is only capable of pumping one gallon per minute.

"If they drain my well, I worry where am I left." Bryan Lewis, chairman of Central Esquesing Ratepayers Association, said the previous pump test revealed it impacted wells in the area.

He is also concerned the pump test could result in flooding and may impact aquatic life in streams the water is directed into.

Halton hydrogeologist Steve Holysh said the pump





test will not result in flooding and there will be no damage to creeks and wildlife.

He said, when a two-day pumping test was done on the well in 1991 none of the neighbouring wells dried up "but the water level did drop in some of the wells closest to the pumping well."

"We are doing the test to make sure we're not going

to interfere with anyone's water supply," said Holysh. "If it can't yield the water we want on a long-term sustainable basis, we will not put a well there."

Halton Region is hosting an information meeting on the upcoming pumping test in the council chambers at the Civic Centre at 7 p.m. tomorrow (Thursday).


