Residents are advised pursuant to Section 32 of the Municipal Elections Act, R.S.O., 1990, c.M.53, as amended, that nominations of the candidates in the election for the offices set out below may be filed in the Clerk's Office, Town of Halton Hills, 1 Halton Hills Drive, during regular office hours of 8:30 a.m. to 4:30 p.m. and on "NOMINATION DAY", Friday, October 13th, 2000 between the hours of 9:00 a.m. to 5:00 p.m. A prescribed nomination filing fee (\$100 cash) must accompany the nomination form.

The offices for which candidates may be nominated are:

OFFICE OF MAYOR

- one (1) to be elected at large

OFFICE OF REGIONAL COUNCILLOR

- one (1) to be elected to represent Wards 1 and 2
- one (1) to be elected to represent Wards 3 and 4

OFFICE OF COUNCILLOR

- two (2) to be elected for each of four (4) Wards

to compose the Council of The Corporation of the Town of Halton Hills for a three (3) year term commencing December 1st, 2000. **NOTICE OF A PUBLIC MEETING
ZONING BY-LAW AMENDMENTS
- HORNBY COMMUNITY**

Council for the Town of Halton Hills will conduct a Public Meeting to examine and discuss proposed amendments to Zoning By-Law 74-51 applying to properties zoned "M1" - General Industrial within the Hornby Community. The subject properties are shown on the accompanying map.

In accordance with the recommendations of the 401 Corridor Secondary Plan the Town of Halton Hills will be examining the role of Hornby, as part of the Town's Official Plan Review. Currently, several properties in Hornby are zoned "M1" - General Industrial permitting land uses that may be contrary to the objectives of the 401 Corridor Secondary Plan and the future role and function of the Hornby community. Council has recommended that the zoning of these properties be examined in order to re-zone the properties to the "D" - Development zone. The "D" - Development zone recognizes the future development potential of the lands, but limits the permitted uses to uses by a public authority and those uses legally existing at the date of the passage of the by-law, until the land uses are reviewed in the future.

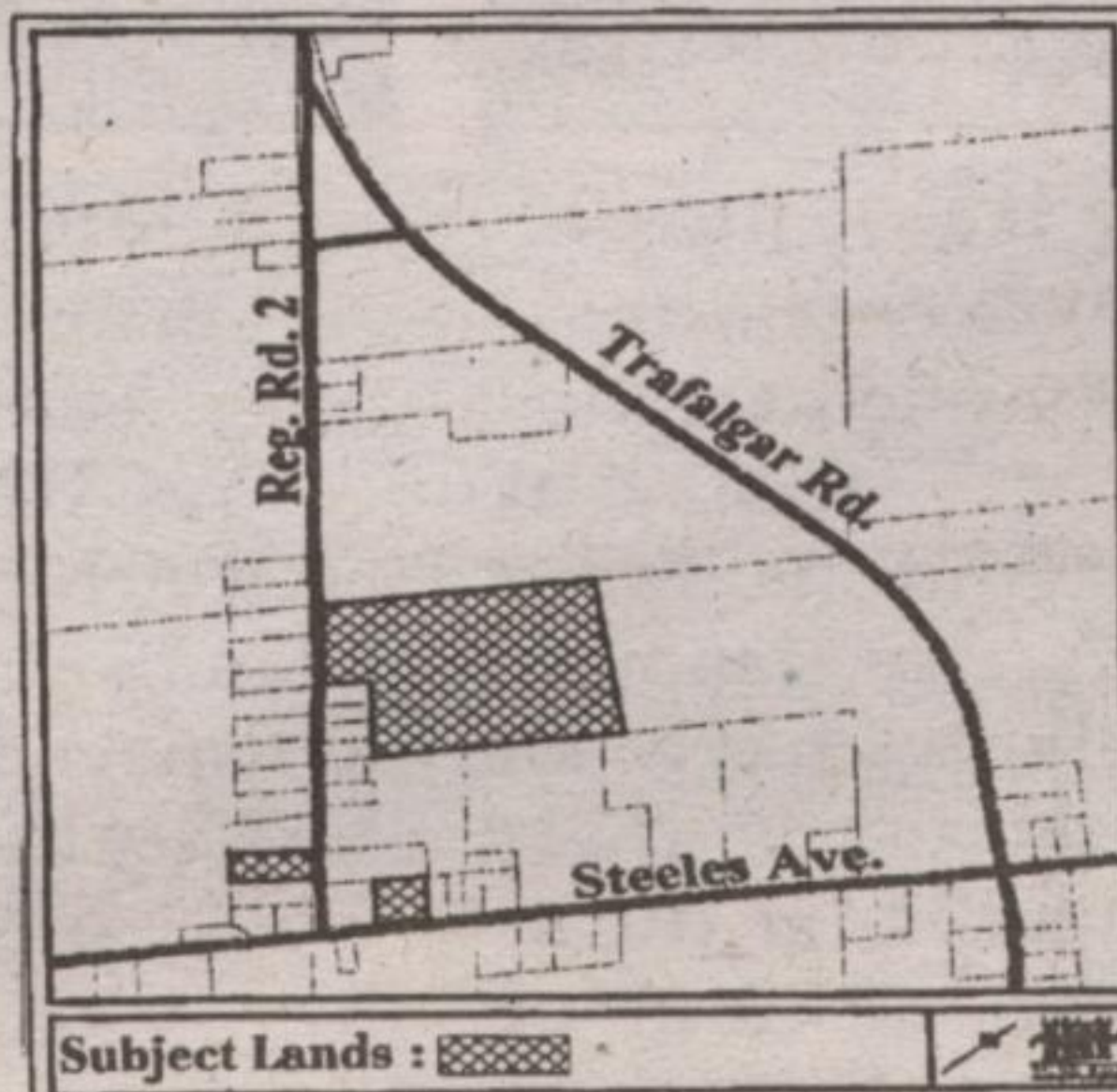
Planning staff will provide additional information at the Public Meeting. The public is invited to attend the meeting and ask questions or provide comments.

If a person or public body that files an appeal of a decision of the Town of Halton Hills in respect of the proposed zoning by-law amendments does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed zoning by-law amendments are adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

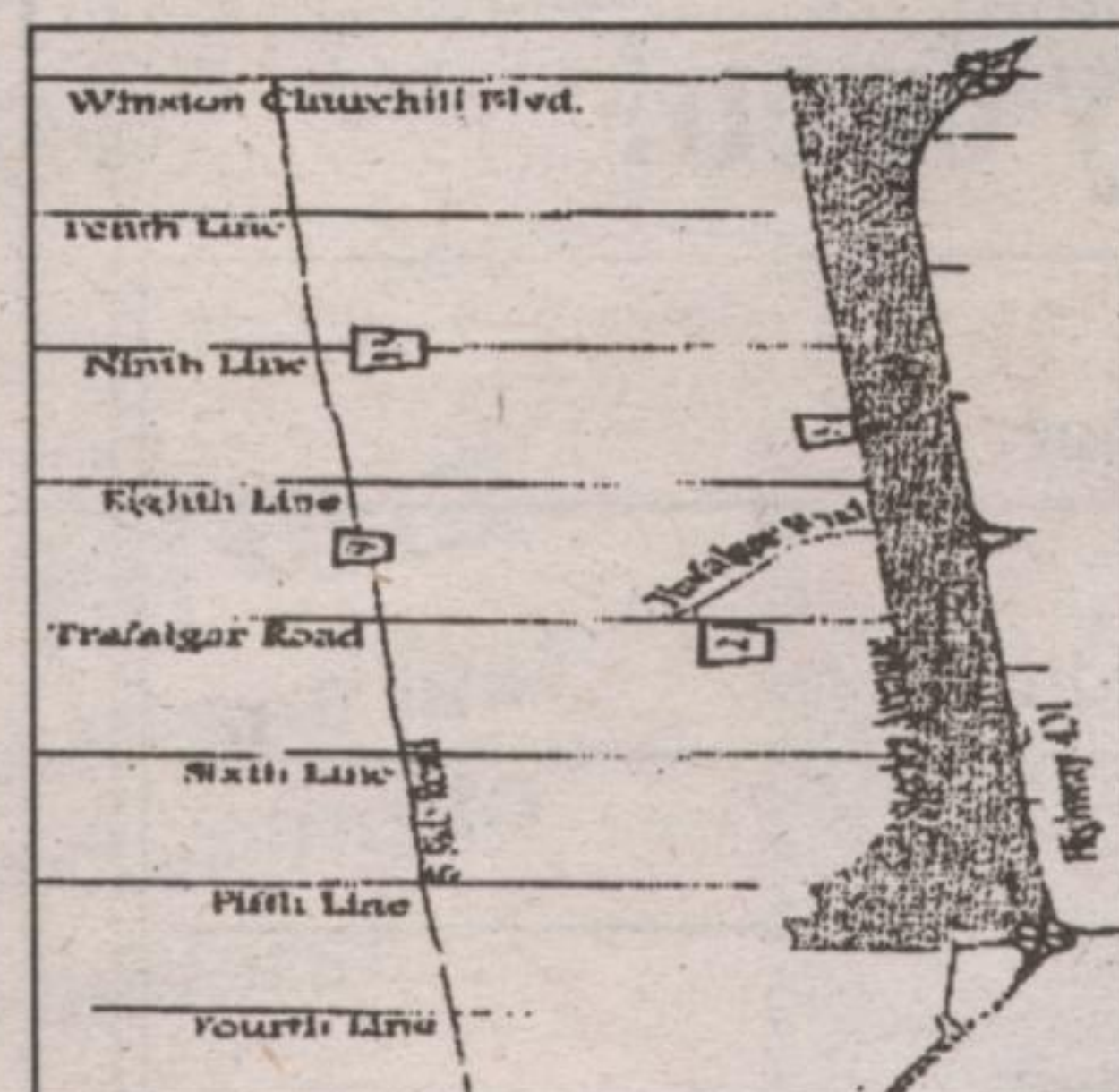

Crime prevention strategies working, says staff sergeant

On the decline in town so far this year are fraud offences (45.8 per cent), auto thefts (16.3 per cent), thefts over \$5,000 (12.5 per cent), and thefts under \$5,000 (1.7 per cent).

In Halton statistics show decreases in robberies (20 per cent), auto thefts (21.2 per cent) and break-ins (2.8 per cent).

"Crime prevention strategies were used and resulted in a decrease," said Halton Regional Police Sgt. Frank Phillips. Increases occurred in a number of areas including sex offences (19.7 per cent), offensive weapons (61.4 per cent), domestic assault (4.4 per cent) and fraud (19.2 per cent).

There was also an increase in property damage (9.5 per cent) and stolen property (11.7 per cent).

"The largest increase was in relation to offensive weapons from 51 to 83 occurrences," said Sgt. Frank Phillips.

Phillips said the increase was due to a backlog of cases that originated in 1999, but weren't recorded at the time.

A number of the weapon charges were minor.

"Many of these offences, although criminal, are of a minor nature, such as a registered firearm owner not notifying a change of address," he said.

Each district of Halton police has a crime analyst officer who identifies crime trends and, with a community officer, develops a strategy to target the identified crimes, Phillips said.

"The Halton Regional Police Service will continue to deploy officers to address areas of increase," he said. "This will be done by both targeted and increased enforcement through the use of crime analysis."
