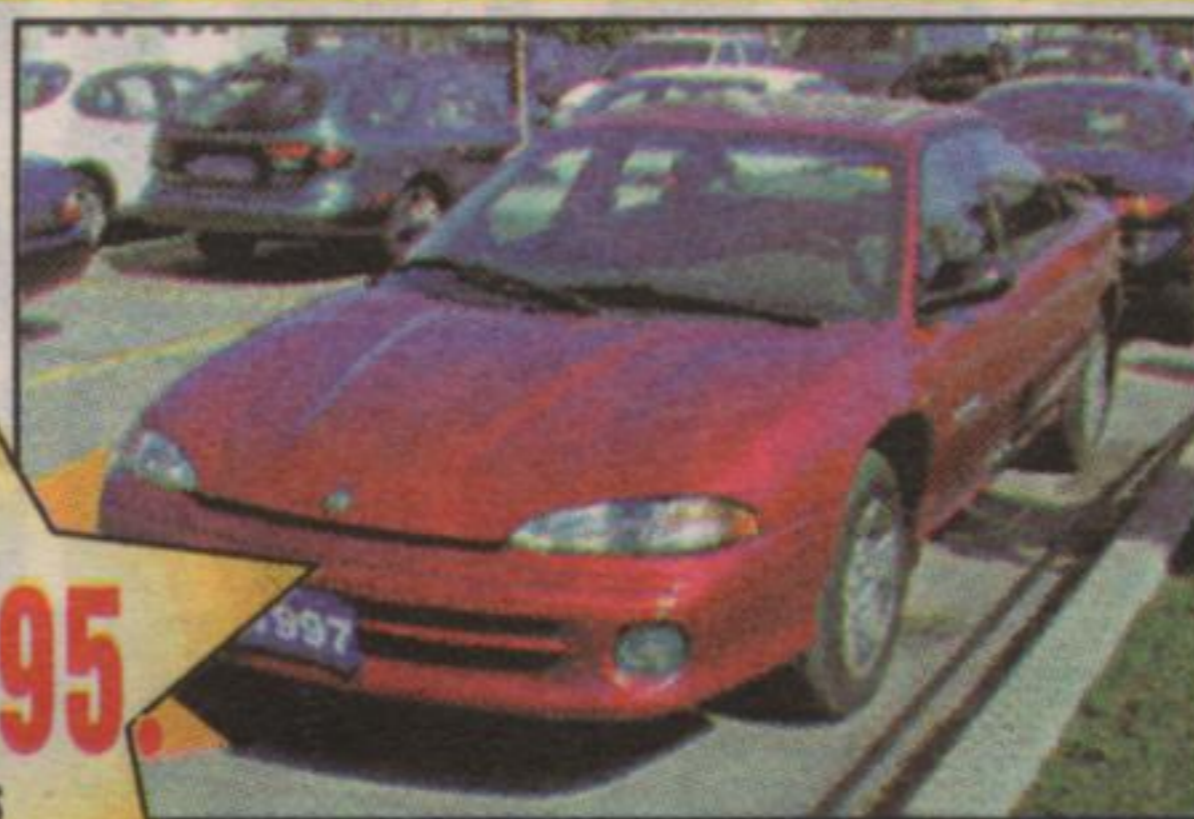

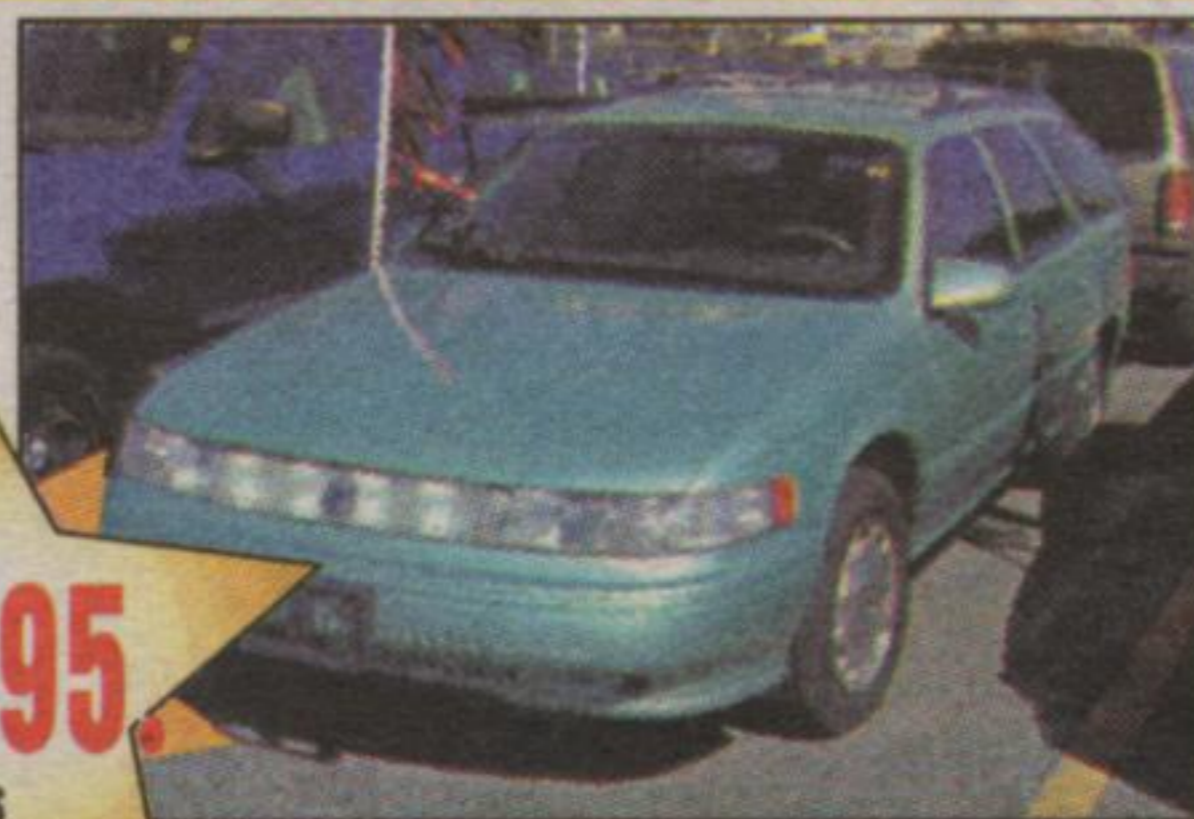

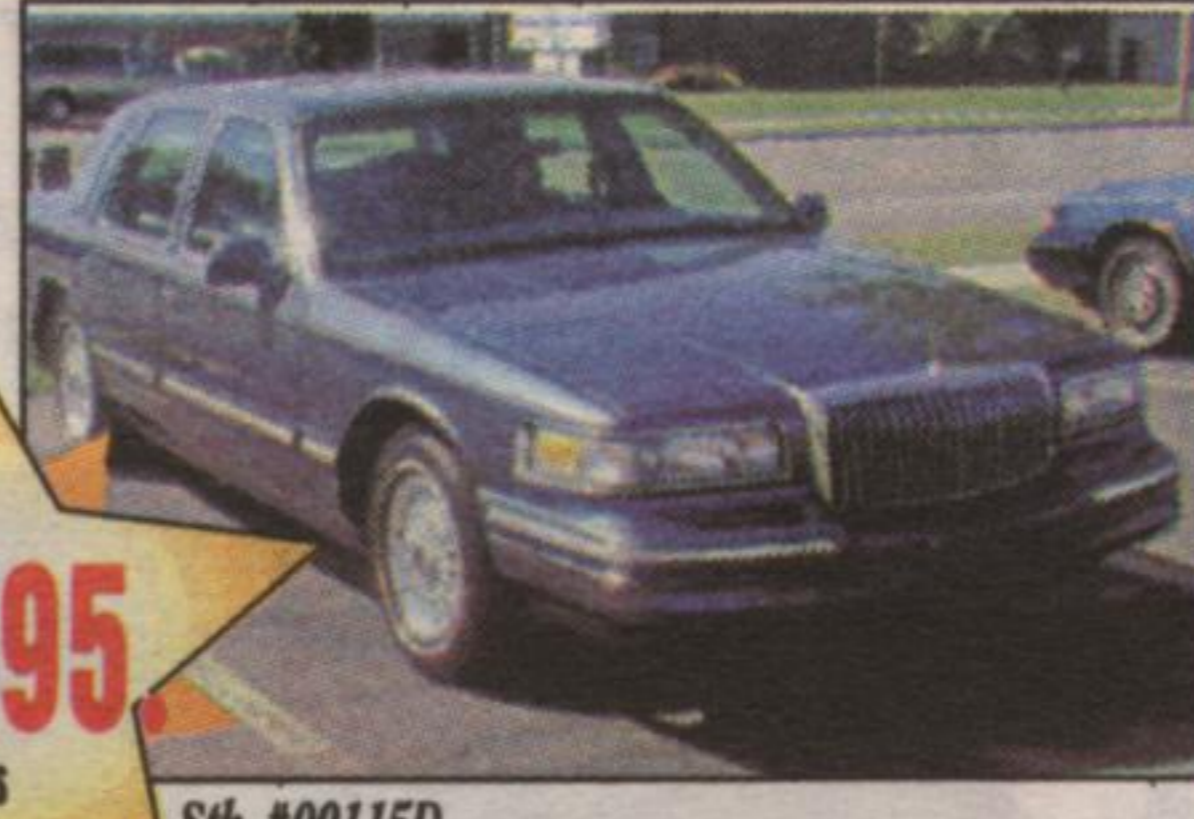

ARE YOU ON THE VOTERS LIST?

The preliminary voters' list will be posted at the Town of Halton Hills, Civic Centre, 1 Halton Hills Drive, Georgetown, commencing Friday, September 1st, 2000.

Electors should examine the list to ensure that their names and relevant information are correctly shown:

Any individual may call the Town Clerk's Office during regular office hours at 905-873-2600 to make inquiries regarding their status as an elector and their school support.

A PERSON MAY MAKE APPLICATION REQUESTING THAT:

1. his/her name be added to or removed from the voters' list; or
 2. information on the voters' list relating to the person be amended
- between Tuesday, September 5th, 2000 and Wednesday, November 8th, 2000 at the Clerk's Office:
or
on Voting Day, November 13th, 2000 at the location designated for you to vote.

A PERSON MAY MAKE APPLICATION REQUESTING THAT:

3. another person's name be deleted from the voters' list by filing an application on the prescribed form with the Clerk at the Civic Centre.

between Tuesday, September 5th, 2000 and Friday, October 13th, 2000.

VOTING PROXIES

Any elector may appoint another eligible elector as his or her proxy. The forms to appoint a proxy are available at the Town Clerk's Office after October 13th, 2000. The individual who is to be appointed as the proxy must attend the Town Clerk's Office in order to take a declaration.

An individual may act as a proxy for only one individual. This restriction on the number of appointments does not apply if the individual is acting as a proxy for a spouse or same sex partner, sibling, parent, child, grandparent or grandchild.

VOTES PAR PROCURATION

Cette limite au nombre de désignations ne s'applique pas si la personne agit à titre de fondé de pouvoir pour conjoint ou conjointe ou du partenaire de même sexe, frère ou sœurs, parents, enfants, grands-parents ou petits-enfants.

- must remain after closing of the polls to count ballots and to return all election materials to a specified location
- must attend a training session
- if selected to work at the Advance Poll, being **Saturday, November 4, 2000 or Wednesday, November 8, 2000** you must also be available to return to the municipal office after polls close on the regular voting day to count sealed ballots.
