

Face fraud charges

Two Georgetown residents have been charged with fraud over \$5,000 in connection with welfare fraud that occurred between last August and June 2000.

Halton Police report the fraud occurred when a woman informed Halton Region she was living alone, but wasn't.

Charged with four counts of uttering forged documents, three counts of perjury as well as fraud over \$5,000 is Krista Eastwood, 30, of Daniela Crt.

Also charged with uttering a forged document and fraud over \$5,000 is Joseph Chiasson, 29, of Daniela Crt.

Halton Police are warning seniors to be on the lookout for suspicious people after a man was seen attempting to get into the side door of the senior's apartment building on Elizabeth Dr. in Acton Wednesday morning.

He was later seen going in the front entrance of the building and using the intercom. A resident received a call from the lobby and let in who they thought was their son, but he never came to their door.

The man is described as white, clean-shaven with black hair, 30, 5'7" and 170 lbs. He was wearing

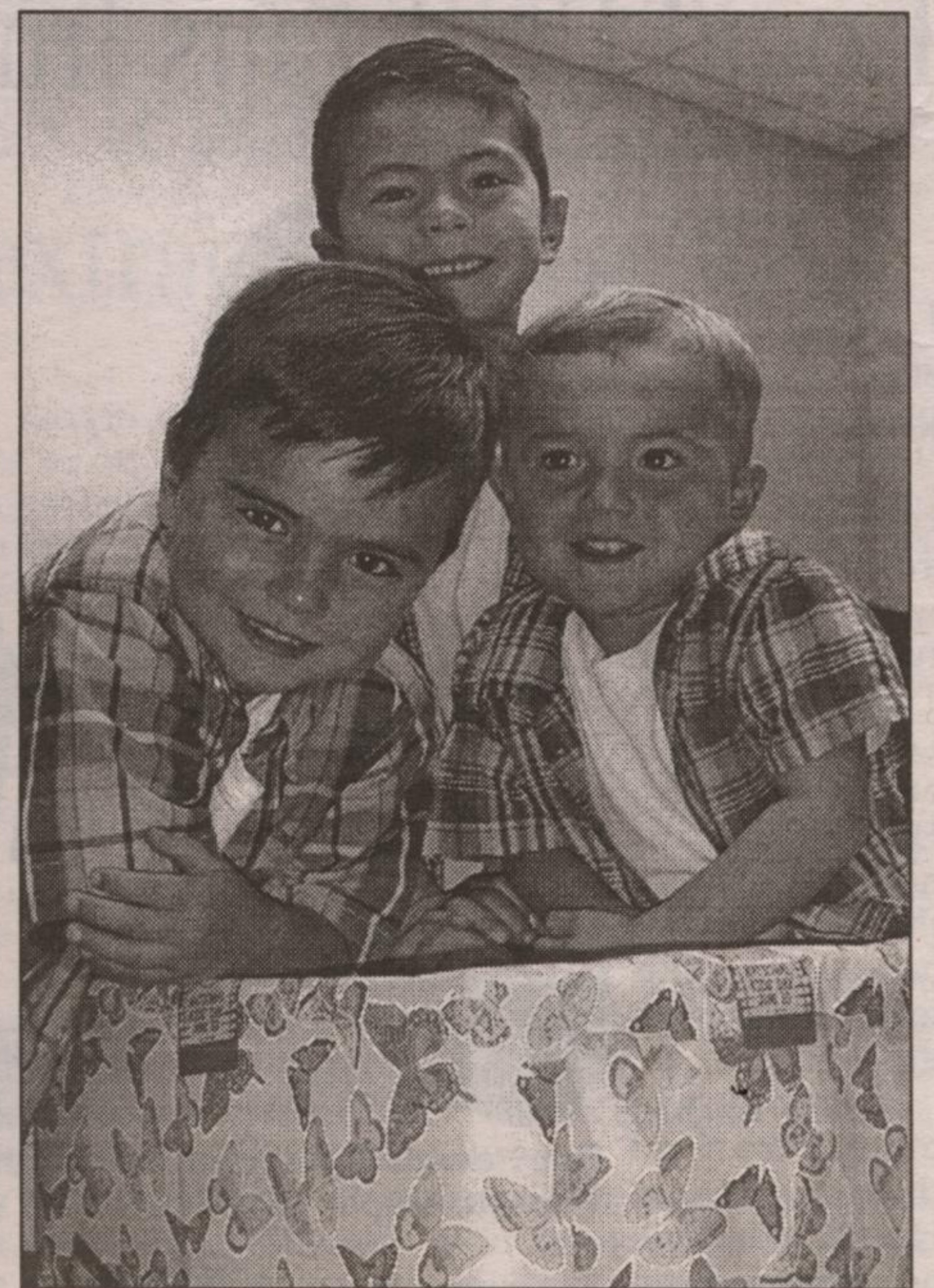
jeans and a jean jacket.

They received another report of a similar incident on Prince St. the same day but don't know if the two incidents are related. The woman was seen getting into a van.

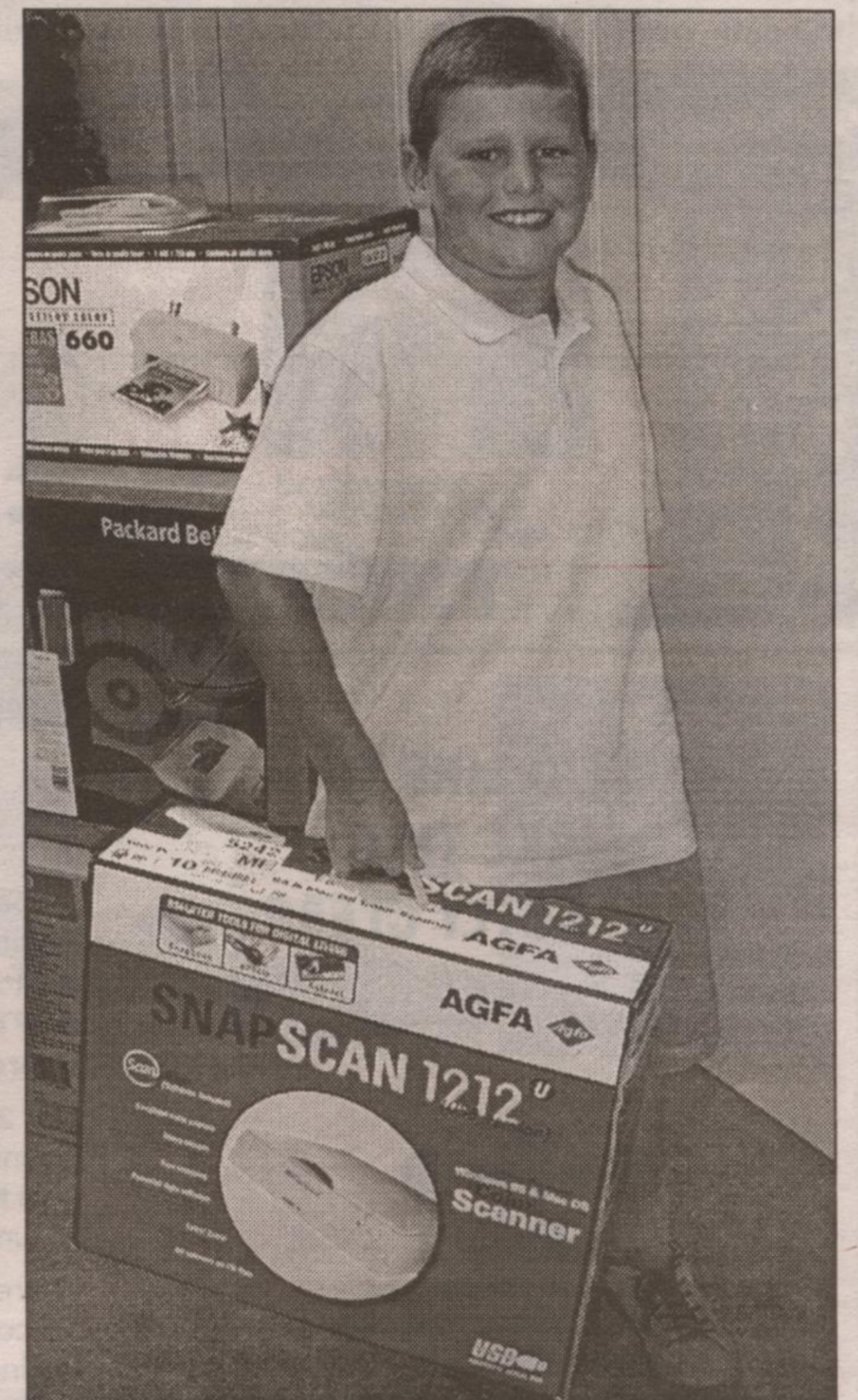

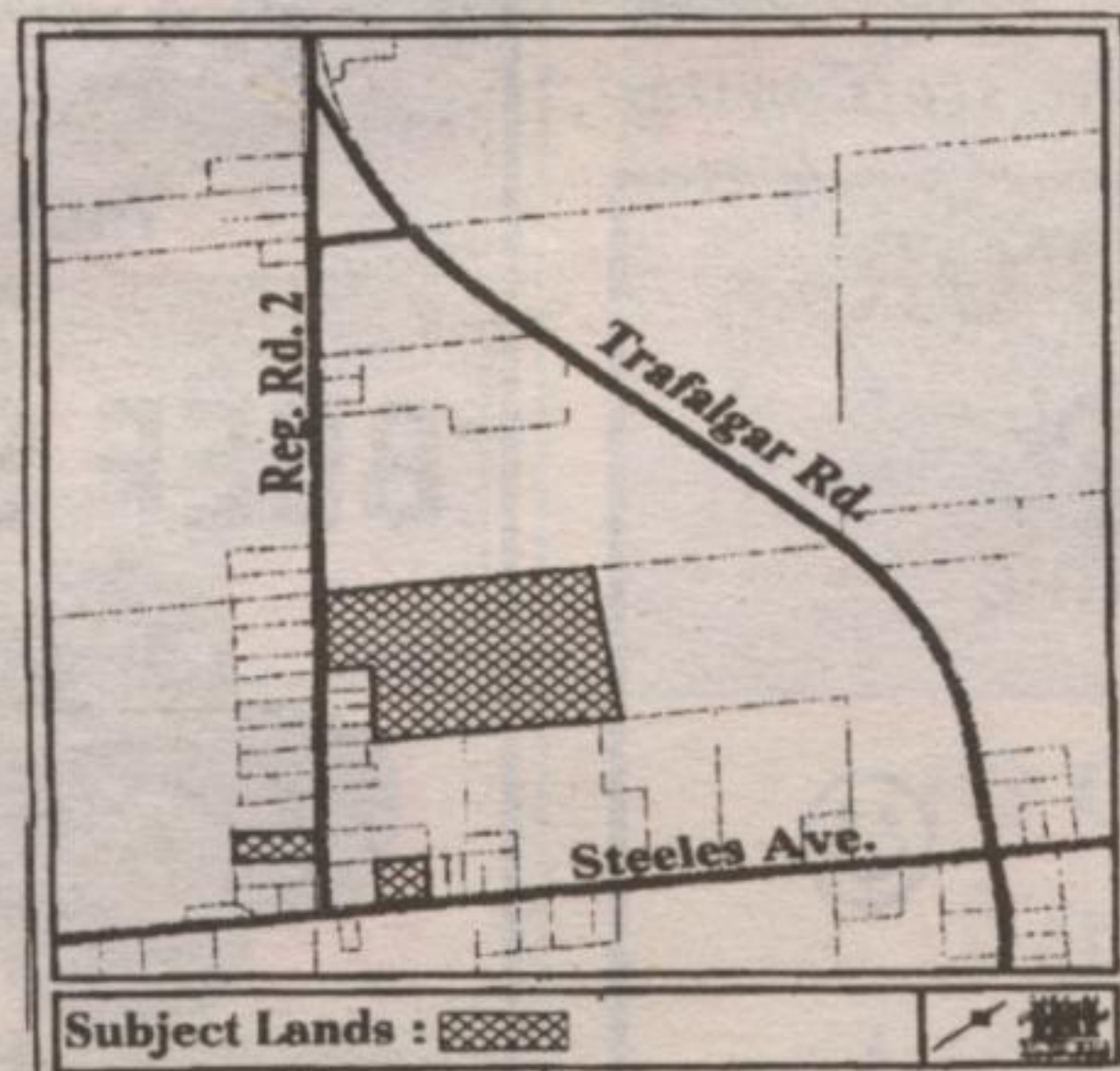

PUBLIC MEETINGS

NOTICE OF A PUBLIC MEETING ZONING BY-LAW AMENDMENTS - HORNBY COMMUNITY

Council for the Town of Halton Hills will conduct a Public Meeting to examine and discuss proposed amendments to Zoning By-Law 74-51 applying to properties zoned "M1" - General Industrial within the Hornby Community. The subject properties are shown on the accompanying map.

In accordance with the recommendations of the 401 Corridor Secondary Plan the Town of Halton Hills will be examining the role of Hornby, as part of the Town's Official Plan Review. Currently, several properties in Hornby are zoned "M1" - General Industrial permitting land uses that may be contrary to the objectives of the 401 Corridor Secondary Plan and the future role and function of the Hornby community. Council has recommended that the zoning of these properties be examined in order to re-zone the properties to the "D" - Development zone. The "D" - Development zone recognizes the future development potential of the lands, but limits the permitted uses to uses by a public authority and those uses legally existing at the date of the passage of the by-law, until the land uses are reviewed in the future.

Planning staff will provide additional information at the Public Meeting. The public is invited to attend the meeting and ask questions or provide comments.

If a person or public body that files an appeal of a decision of the Town of Halton Hills in respect of the proposed zoning by-law amendments does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the pro-
