Regional council calls for tax freeze when staff draw up 2001 budget

I taff should aim for a tax freeze in drawing up the 2001 budget, Halton Regional Council decided Wednesday.

Service improvements of up to two per cent, excluding policing costs, will also be considered in the upcoming tax budget, which should be approved in February.

But, Milton Mayor Gord Krantz wondered why the Halton Regional Police Services budget— which routinely eats up a fair portion of the tax bill and has come in at an increase for the past several years— isn't pushed to make the same commitment.

"I wonder why police would be excluded from trying to keep it at zero," he said at Wednesday's regional council meeting.

Police are caught between Halton's pressure to keep the budget down and costly mandated adequacy standards passed on by the province, explained Oakville Councillor Keith Bird, who also sits on the Police Services Board.

"We don't have the latitude to pick and choose or ignore those things," he said. "We understand the challenges very clearly, but we can't ignore the Police Services Act."

The annualization of previouslyapproved new officers will also have an impact on the upcoming budget, said Oakville Mayor Ann Mulvale.

Historically, the lion's share of the police budget goes to salaries, and Halton's growth has triggered a hiring spurt to keep up.

Currently, the police portion of the tax

bill is separated from the region's share to show taxpayers where their money is being spent.

Mulvale asked the police costs be further broken down so it can be clearly shown what percentage of its budget is spent on fulfilling the provinciallyimposed standards.

But taxpayers are mainly interested in the bottom line, said Burlington Mayor Rob MacIsaac.

"It's a little like saying the regional tax bill is at zero, except in the places where it isn't at zero," he said.

And to keep a lid on the total tax impact in spite of escalating policing costs, other requirements have been put on hold, said Oakville Councillor Stephen Sparling.

"There are other areas we need to spend money on and we haven't been able to do that," he said. "We have real needs where we need to invest."

But he has yet to hear a constituent complain about the cost of policing, added Sparling.

The region remains committed to keeping the tax burden as low as possible for residents, said Halton Chair Joyce Savoline.

"Zero is our goal," she said. "I know how diligent we are to keep it at zero."

And the police bottom line will be as low as possible while staying within the provincial guidelines, said Bird.

"If it comes in at less than zero we'd be delighted," he said. "But don't hold your breath."


