ocal residents have decided to turn a failure to stop the closure of the -Georgetown Canadian Cancer Society (CCS) office into an opportunity to create their own patient services organization.

More than 100 people attended a public meeting at Holy Cross Church Hall Thursday to hear about the dissolution from the CCS by local volunteers and the creation of a new group— the Cancer Assistance Services (CAS) of Halton Hills.

Dianne Penrice, former Georgetown CCS branch president, said local volunteers will continue their CCS duties until the final closure of the Georgetown office. That's scheduled for Nov. 30, but "given the tion, and research.

change in circumstances" it's possible it may be closed sooner, said a CCS spokesperson.

The Acton branch has decided to remain with the CCS, but will align itself with the Guelph office, instead of the Oakville unit, branch president Cathy Gerrow said. Milton CCS volunteers are joining the Burlington unit.

Also announced at the public meeting was the resignation of all the executive members of the Georgetown CCS branch. They are Dianne Penrice, Bob Bairstow, Ted Gorth, Lorrie Kelly-Quinn, Doug Millinder, Barry Timleck and Jenny Tuffin. The CCS was informed of the decision on Friday.

"We are too tired to

fight anymore," said Kelly-Quinn, an executive member of the new CAS. "We feel everybody will be serviced so much better in our own community."

"I am saddened at the news that the Georgetown council members have decided to resign to create their own organization," said Ted Wheatley, president of the CCS, Ontario Divison in a statement to The Independent & Free Press Tuesday.

"I still believe that we could have worked together to achieve a smooth transition and to provide patient services in a different way. It is unfortunate the Canadian Cancer Society was not given the opportunity to provide transition support to the Georgetown volunteers so that we could show that we are fully capable of providing patient services without the use of a local office space," Wheatley wrote.

However, an impetus to creating the new Georgetown group was CCS's decision to withdraw funding for some patient services (not transportation). The CCS decided at its Sept. 29 Ontario directors board meeting, it would withdraw financial assistance for all medical services Jan. 15 and some non-medical services July 31.

"They want the communities to find this funding and make all arrangements for these services," said Dianne Penrice, former Georgetown CCS branch president. "Well, if we are going to do that, why not just do it for ourselves?"

The CAS's purpose will be to provide the

following volunteer services to patients: transportation, emotional support groups, friendly visiting, lending library of books, videos and education materials, referrals to other agencies, preventative education programs, in memoriam cards, chemo hats (which are Georgetown-made), wigs, and Reach To Recovery pillows.

In the future, depending on fund-raising, the group hopes to provide babysitting, respite care, equipment loans, approved financial assistance and boarding out.

Christine Koserski, CCS communications co-ordinator, stressed the CCS will continue to provide its four cornerstones: transportation services, peer support, informa-

> Koserski pointed out CCS surveys have revealed the majority of cancer patients want and find these four services the most useful.

Locally, CAS's mandate will be strictly patient services for all Halton Hills residents it will not raise money for cancer research. People who wish to continue to raise or donate money for cancer research should continue to support the CCS, Terry Fox Foundation or other cancer research organizations, said Penrice.

"Research is very important," Penrice told the supportive crowd, "but we're here to support patients in the community."

Incorporation of the new group is expected this week, with name registration and a charitable

number to follow in subsequent months.

The new CAS board of directors will be Penrice, president; Bob Stuart, vice-president; Tracey Bastedo, treasurer; Rita Bairstow, secretary; and executive members Jan Cook, Karen Harrison, Kelly-Quinn, Bill Smith, Diana Stuart and Timleck. Operating details are being modeled after a Hamilton group which made a similar break from the CCS about a year ago.

The group is currently look for office space— "a cubby hole" is satisfactory. Donations are being accepted, and at Thursday's meeting Doug Penrice got the ball rolling by donating his \$200 provincial government rebate cheque. By the end of the evening more than \$1,000 had been raised. Many people also volunteered. Dianne Penrice indicated during the meeting corporate donations will also be forthcoming.

Since there is no charitable number yet, all in memoriams, and donations are being recorded and receipts will be sent out next year as soon as CAS receives its charitable registration number. The group also plans to do a fund-raising campaign throughout the year, except April (that's the cancer society's traditional campaign month).

"We're not trying to steal anything here (from the CCS), we're trying to give it (service) back," said finance chair Barry Timleck.


