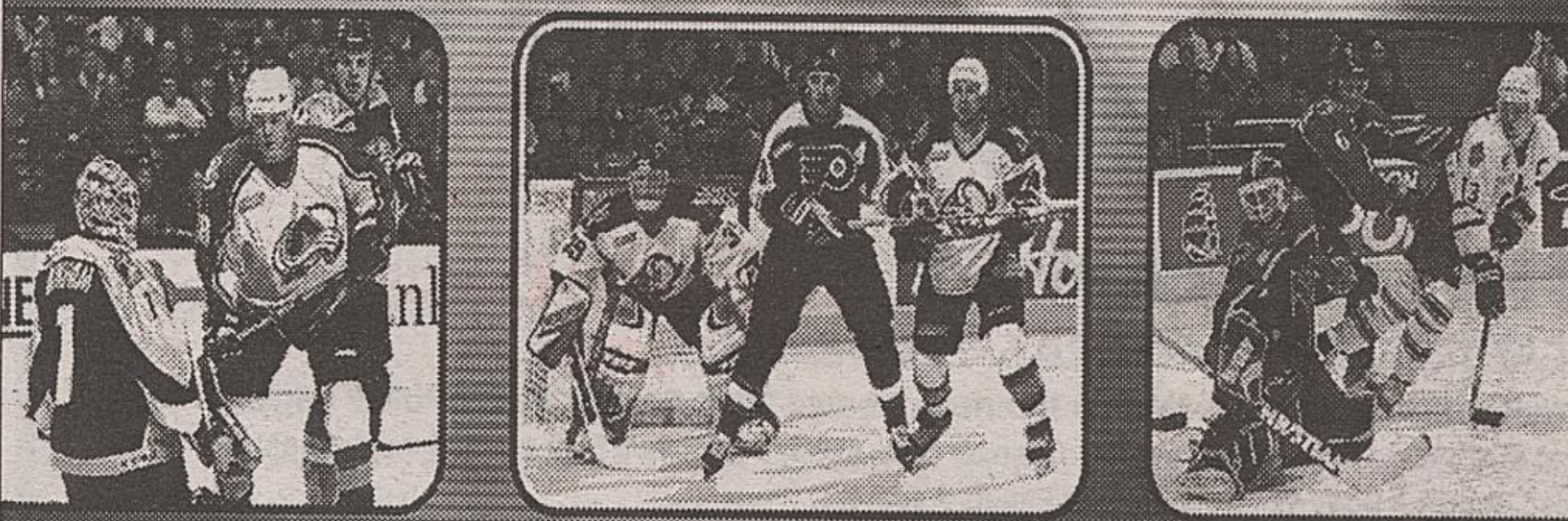
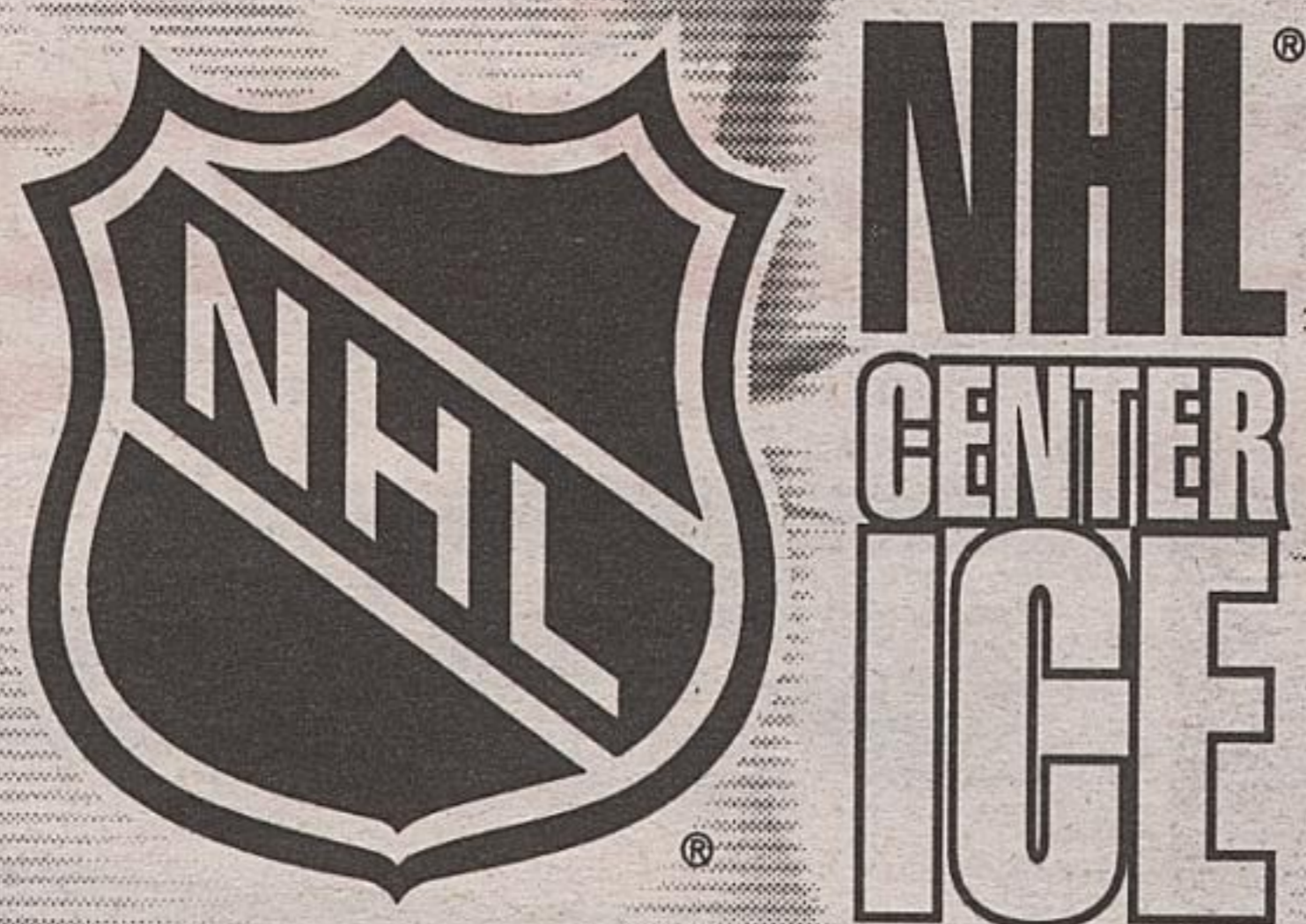

## BY-LAW NOTICE

FORM 1

PLANNING ACT

NOTICE OF THE PASSING

OF ZONING BY-LAWS BY

THE CORPORATION OF THE CITY OF MISSISSAUGA

TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed By-laws 0484-2000, 0485-2000 and 0486-2000 on the 11<sup>th</sup> day of October, 2000, under Section 34 of the Planning Act R.S.O., 1990, c.P.13, as amended.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the By-laws by filing with the Clerk of the City of Mississauga not later than the **7th day of November, 2000**, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection, together with a cheque in the amount of \$125.00 payable to the Minister of Finance for each of the By-laws.

Only individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

### Explanation of the purpose and effect of the by-laws:

By-law 0484-2000 to amend Zoning By-law 5500 (former Town of Mississauga), By-law 0485-2000 to amend Zoning By-law 1227 (former Town of Port Credit) and By-law 0486-2000 to amend Zoning By-law 65-30 (former Town of Streetsville) pertaining to accessory buildings and structures (inclusive of attached and detached private garages) and play equipment on residential lots used for a detached, semi-detached or street row dwellings, by:

- further regulate the height, size and placement of accessory buildings and structures (including attached and detached private garages) on residential lots. In some cases, the zone provisions vary based on the area of the host residential lot.
