Along with his wife Marilyn, Lo Turco had to bring in some new tables and equipped the Caffé with a highend Gaggia espresso and cappuccino machine.

Now the shop offers a full lunch menu, featuring sandwiches, pastas, lasagna and chicken and veal in various dishes.

And, in Lo Turco's words, "the best coffee in town."

He also offers sinfully rich cakes and desserts, and both hot and cold espresso, cappuccino, caffé latte and mocacino.

The Lo Turcos also take on some small catering jobs looking after groups up to 15 people, providing sandwiches or lunch menu items.


Walk-in customers can also order a take-out lunch.
