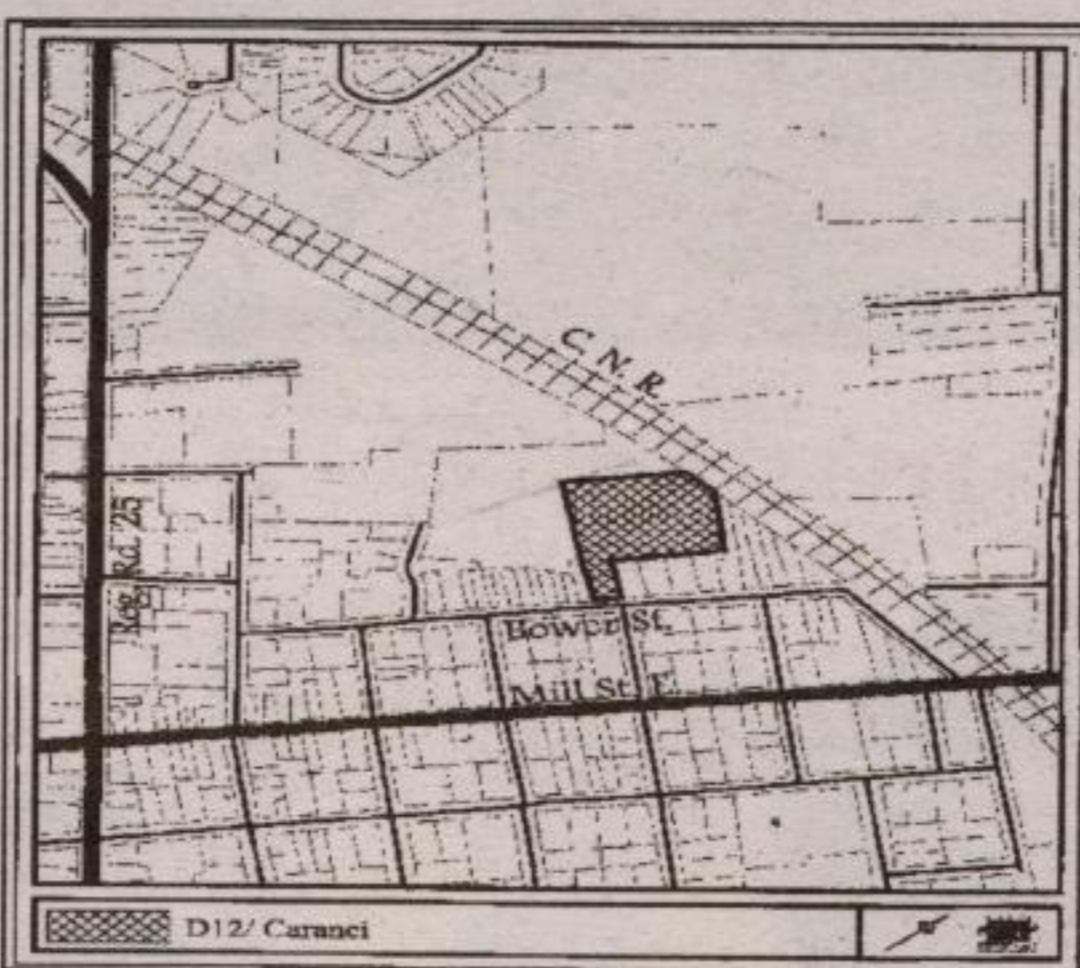
NOTICE OF A PUBLIC MEETING WARD 1 / 97 Bower Street, Acton
