

OMB dates set


The dates have been set for an Ontario Municipal Board (OMB) hearing on the proposed Halton Hills Village Homes Inc. (HHVHI)/Silver Creek Estates subdivision on Main St. S.

During a telephone conference call prehearing on March 8, the OMB scheduled April 15-17 so all sides can hammer out the final conditions for the subdivision, said town solicitor Stephen D'Agostino.

Developers HHVHI and Silver Creek Estates plan to build about 500 homes on Main St. S. lands in Georgetown. However, pre-hearings have been repeatedly delayed due to the region's search for a water supply for new Georgetown development.

During the conference call, Halton Region withdrew its objection to proceeding to the full hearing because there is now an expectation that there is enough water available for 1,250 new single-family detached units over the next three years, D'Agostino said.

The three-day hearing will be held in the Civic Centre, however a public night, scheduled on Monday, April 15, will be held in the Halton Hills Cultural Centre.
