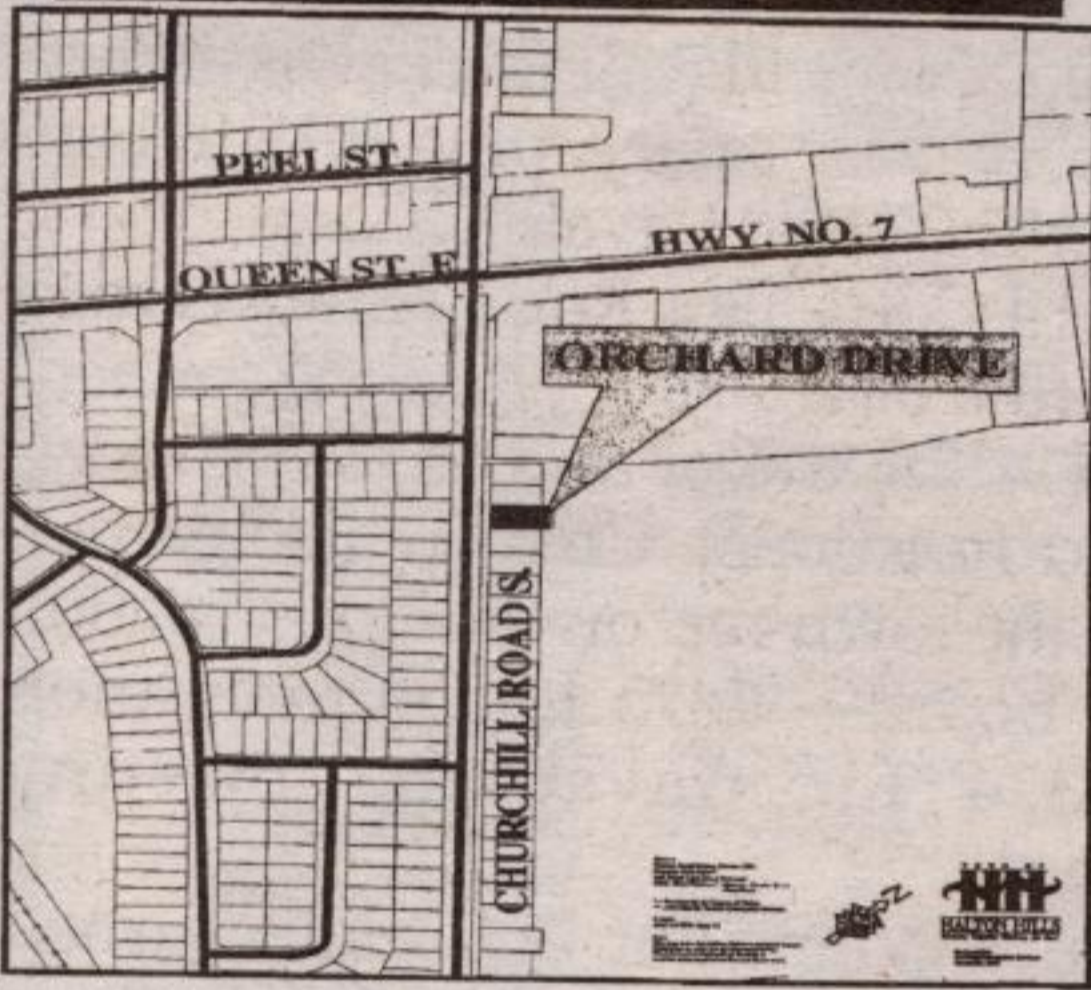

Filming starts today 'Secret Service' to be on patrol at Scotsdale Farm

The show will go on at Scotsdale Farm, the location of a television pilot being filmed there today.

Halton Hills council gave approval to the production company, Millennium Canadian Productions East Limited, a subsidiary of 20th Century Fox, to extend filming past 11 p.m. noise bylaw deadline until 3 a.m. Thursday at a special council meeting Monday.

Filming starts this afternoon at 1 p.m. on a pilot about a Secret Service protection detail of the American vice-president. The plot includes the search for a missing boy on the grounds of the farm.

Pistol firing and a circling helicopter (weather permitting) will be part of the action sequences. Most of the noise will occur during daylight hours.

Producer Michael Mashio told council the company has made every effort to inform area residents about the filming, including going door-to-door with letters.

Mashio said if the show succeeds—and he seemed in little doubt of that, saying it has the inside track—that it would generate about 600 jobs, adding two members of the production company live in Halton Hills.

It will also generate \$23 million of invested capital in Ontario.
