



LATE PAYMENTS?

- A late payment charge of 1-1/4 per cent per month will be charged on the first day of each calendar month until taxes are paid.

NO TAX BILL?

- Bills were mailed January 31, 2002. Failure to receive a Tax Bill does not excuse the Owner from responsibility for payment, nor relieve him/her from liability for late payment charges. Please contact the Finance Department if you did not receive yours.

NEW PROPERTIES?

- Newly built properties are likely to have bills related to their land value assessment only until full assessment is applied and supplementary taxes billed. Owners are responsible for taxes billed and should make provisions for the future billing of supplementary taxes.

SENIORS TAX GRANT

- Residents 65 years or older who qualified for this Grant for 2001 will receive this year's application in the mail. Information and new applications are available at the Tax Department.






General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss applications for a proposed 9 lot rural industrial plan of subdivision (on private services) and a proposed amendment to the Esquesing Zoning By-Law No. 74-51, as previously amended by By-Law 89-84. These two applications relate to approximately 17.681 hectares (43.69 acres) located at the northeast corner of Regional Road 25 and Campbellville Road (5 Side Road) north of the Town of Milton 401 Industrial Park. Road as described above and shown on the attached

The purpose of the proposed applications is to permit the establishment of (dry) industrial uses on the property in accordance with the Town of Halton Hills Official Plan - Rural Industrial Area designation and proposed General Industrial Special M1-2 Zone. The Town of Halton Hills Rural Industrial Area designation for these lands is currently deferred pending further approval by the Minister of Municipal Affairs and Housing. The Halton Region Official Plan permits industrial and ancillary uses on private services on this site.

If you wish to be notified of the Town of Halton Hills Council decision on the proposed plan of subdivision and/or the adoption of the proposed zoning by-law amendment, you must make a written request to the Town of Halton Hills at 1 Halton Hills Drive, Georgetown, Ontario L7G 5G2.

If a person or public body that files a notice of appeal of a decision of the Town of Halton Hills in respect of the proposed plan of subdivision and/or the proposed zoning by-law amendment does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed subdivision and/or proposed zoning by-law amendment is approved and/or adopted, the Ontario Municipal Board may dismiss all or part of the

Also charged with assault with a weapon, utter threats and possession of a weapon for dangerous purposes was a 15-year-old Georgetown male.


School damaged in break-in
