

# Three Harrison Public School students to take part in Children's Conference

They've helped make their school a better place, now they're going to share their ideas with the world.

Three Harrison Public School students have been chosen to participate in the International Children's Conference on the Environment. Grade 4 student Mary Watson and Grade 5 students Jessica Phillips and Ian McIlravey will be delegates at the conference, which is May 20-25 in Victoria, B.C. More than 800 children from 115 countries will take part in the conference.

Harrison has been very active in environmental projects, last year winning a Blue Planet Award for its habitat garden, bird and butterfly garden and a mini forest. All three students are members of the school's Ecolids Club.

The students were chosen after submitting essays on their school environmental projects.

The students will be accompanied by teacher Sandra Runalls-Lichty, who runs the Ecolids Club. The students will participate in workshops, field trips, make presentations about their school's environmental projects and make recommendations that will be forwarded to the World Summit on Sustainable Development.

Protect Our Water and Environmental Resources (POWER) and other community members will help offset some of the costs for the students to attend the conference.

Upon their return, the students will share their experience with their school-mates.

## BY-LAW NOTICE

FORM 1

PLANNING ACT

NOTICE OF THE PASSING

OF ZONING BY-LAWS BY

THE CORPORATION OF THE CITY OF MISSISSAUGA

TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed By-laws 0197-2002, 0198-2002 and 0199-2002 on the 24th day of April, 2002, under Section 34 of the Planning Act R.S.O., 1990, c.P.13, as amended.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the By-laws by filing with the Clerk of the City of Mississauga not later than the **21st day of May, 2002**, a notice of appeal setting out the objection to the By-laws and the reasons in support of the objection, together with a cheque in the amount of \$125.00 for each of the By-laws payable to the Minister of Finance.

Only individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

### Explanation of the purpose and effect of the by-laws:

By-law 0197-2002 to amend Zoning By-law 5500 (former Town of Mississauga), By-law 0198-2002 to amend Zoning By-law 65-30 (former Town of Streetsville) and By-law 0199-2002 to amend Zoning By-law 1227 (former Town of Port Credit), by:

- adding the following provisions related to private garages in detached, semi-detached, row and street row dwellings:
  - (a) where a private garage is required or provided, the private garage shall have a rectangular area with a minimum width of 2.75 m (9.0 ft.) and a minimum length of 6.0 m (19.7 ft.); the parking space within the private garage shall have an unobstructed space with a minimum width of 2.75 m (9.0 ft.), a minimum length of 5.2 m (17.1 ft.) and a minimum height of 2.0 m (6.6 ft.);

- (c) for building permits issued on or before December 24, 2002, the provisions of (a) and (b) noted above or the following provisions shall apply:
  - (i) for detached and semi-detached dwellings, the private garage shall have a minimum area of 16.5 m<sup>2</sup> (180 sq. ft.);
  - (ii) for row and street row dwellings, the private garage shall have a minimum area of 13.5 m<sup>2</sup> (145 sq. ft.);

• enacting housekeeping amendments to sections of the Zoning By-laws by the foregoing.
