Lads and lassies to gather Saturday Kick up your heels at the Highland Games

It's time to break out the pipes and kilts, put on your dancing shoes or put your strength to the test.

The 27th Annual Georgetown Highland Games returns to the Georgetown Fairgrounds this Saturday. And being the first games of the year, the Georgetown games always attract a good field of competitors.

"They're itching all year to get out and this is their first chance," said the games' master of ceremonies Bill Miller.

Twenty-four bands will compete, including a special performance by the Toronto Police Show Band. There will be more than 460 highland dancers competing in five divisions from primary to premier. And a new addition to the games this year is the women's division in the heavyweight competition. The women will participate in the same events as the men except for the farmer's walk.

Rev. Peter Barrow, a founding member of the Georgetown games, will be the honorary chieftain for this year's event.

Although the games started as a celebration of Scottish culture, he said the appeal now extends beyond the Scottish community.

"It's different. There's different food, different culture, it has lots of colour and there is tons of stuff for kids. It's a very good time for the whole family,"

There will be a rock climbing wall, Pictish face painting, floral garlands as well as the popular clan village. The village features displays and history of Scottish families.

There will also be livestock displays and a sheep dog herding demonstration.

Miller said there are a lot of new families in the area and encourages them to come out to the games.

"I'm hoping the locals come out and support us as they have in the past," he said. "Those who haven't been to the games before should come and see what's here. It's a very good time."

POWER to get \$60,000 for project

Protect Our Water and Environmental Resources (POWER) will receive \$60,000 from Environment Canada's EcoAction Community Funding program for its Trees 2002 to 2004 -Restoring Our Ecosystems project.

The project will address the problem of forest fragmentation through restoration at four different sites in Halton Hills.

Through the project, approximately 2,500 students will participate in the planting of 4,700 native trees and erect 15 nest boxes.

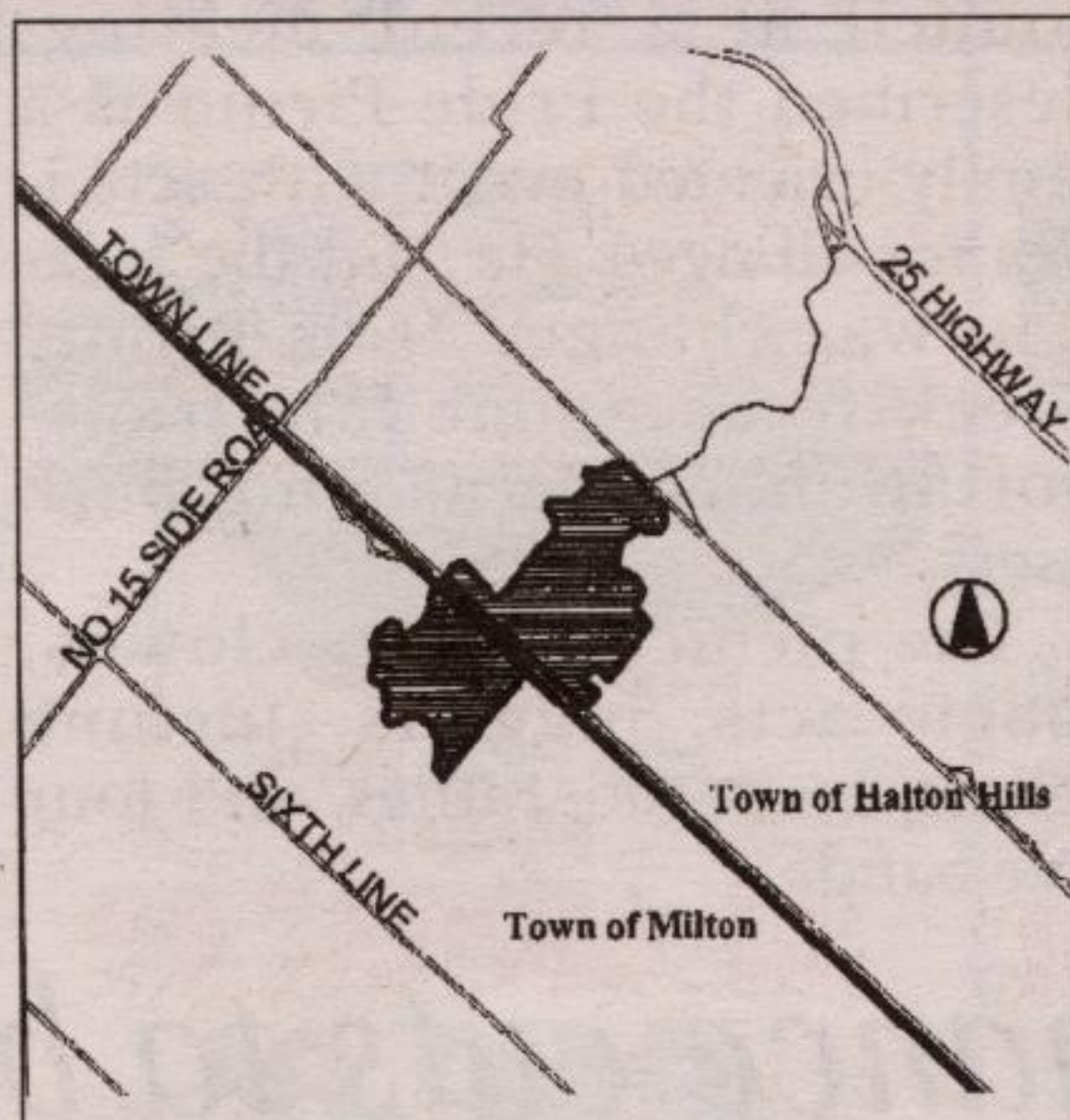
EXPLANATION OF THESE MEETINGS:

Applications have been made by Dufferin Aggregates to: amend the Niagara Escarpment Plan (Amendment 135) and obtain a Development Permit; the Region of Halton Official Plan (amendment 18); the Town of Halton Hills Official Plan (amendment 103); and the Town of Milton Official Plan and Zoning By-law, to permit aggregate extraction to the north and east of the existing North Quarry in Milton.

The lands involved are located within Lots 13 and 14, Concession 1 (Esquesing) in the Town of Halton Hills (47 ha) and Lots 12-14, Concession 7 (Nassagaweya) in the Town of Milton (36 ha). A total of 70 hectares is proposed for extraction of the 83 hectares proposed to be licensed by the Ministry of Natural Resources under the Aggregate Resources Act. The site is shown on the map below.

Staffs have completed their review and are providing a report with recommendations for consideration at the meetings noted above. It should be noted that in the case of the Region of Halton and the Town of Halton Hills, any recommendations coming out of their Committee meetings will require ratification by their respective Councils at the next Council meeting. In the case of Milton, the application is being presented directly to Town Council.

It should be noted that the Niagara Escarpment Commission has not scheduled a date to consider the applications before it. The amendments to the Regional and Municipal Official Plans must conform to the Niagara Escarpment Plan.
