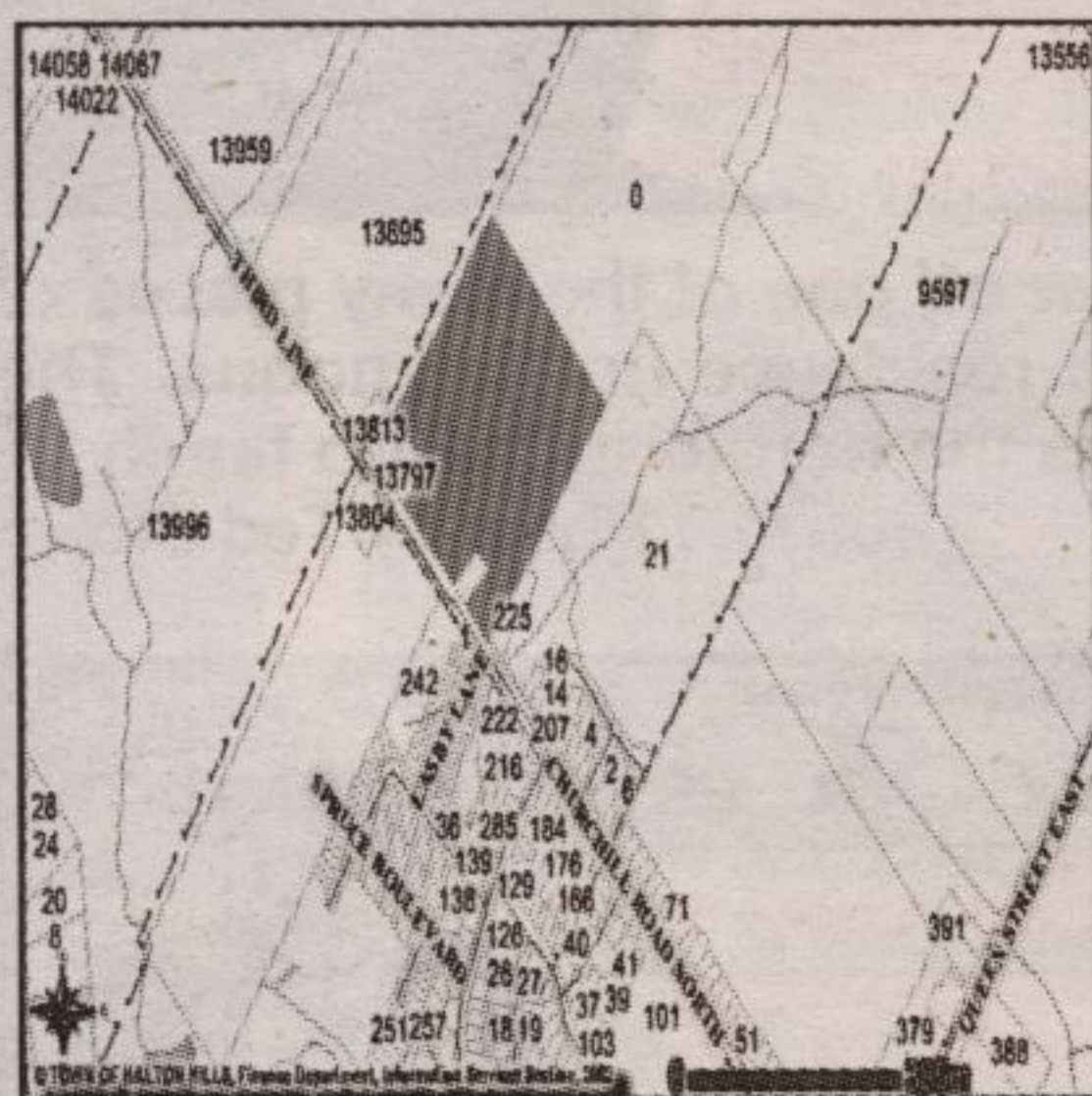
**NOTICE OF A PUBLIC MEETING**  
**WARD 1 and WARD 2/Part of Lot 29,**  
**Concession 4**  
**Elli-Fin Construction, Acton/Esquesing**

General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed nine (9) Lot plan of residential subdivision, plus one (1) retained estate lot, and related amendments to the Zoning By-law 1358, as amended, and Zoning By-law 74-51, as amended, for the Town of Halton Hills. The applications relate to a proposed subdivision, approximately 0.69 hectares (1.697 acres) in size, and a retained estate lot of 8.76 hectares (21.6 acres), being located north of, and abutting 225 Churchill Road (Acton), Part of Lot 29, Concession 4. The property is currently vacant forest, and fronts onto Churchill Road (Third Line).

The proposed Zoning By-Law Amendment to By-law 1358, as amended, would change the zoning on the property from the current "Rural (RU) Zone" (By-law 74-51) to "Holding Residential Sixth Density Special (H-R6-1) Zone" (By-law 1358) to facilitate the development of a nine (9) lot subdivision.

The proposed Zoning By-law Amendment to By-law 74-51, as amended, would change a portion of the retained estate lot from the current "Rural (RU) Zone" to a "Inherent Hazard Lands Special (OS2-1) Zone" to further restrict one (1) currently permitted residential development, and ensure the continued protection of the existing surrounding natural environment.

If you wish to be notified of the adoption of the proposed Subdivision and/or the Zoning By-law Amendments and/or the decision of the Town of Halton Hills in respect of these applications, you must make a written request to the Town of Halton Hills at 1 Halton Hills Drive, P.O. Box 128, Georgetown, Ontario L7G 5G2.



If a person or public body that files an appeal of a decision of the Town of Halton Hills in respect of the proposed subdivision and/or proposed Zoning By-Law Amendments and does not make oral submissions at a public meeting or make written submissions to the

Town of Halton Hills before the proposed subdivision and /or proposed Zoning By-laws are adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

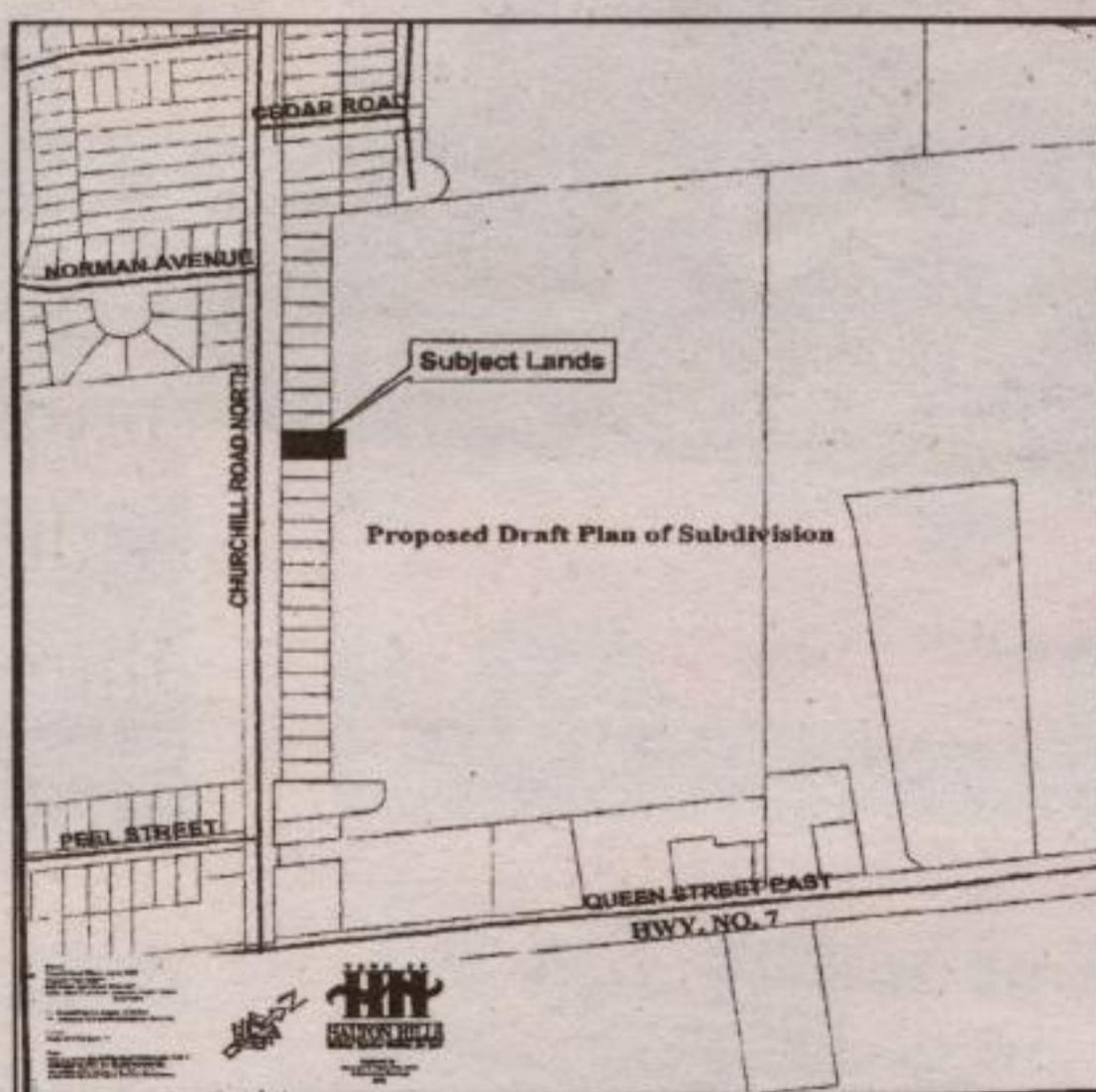

## Reed to forward homelessness concerns

Homelessness concerns in Halton will travel to Ottawa with local MP Julian Reed thanks to the efforts of a group lobbying for affordable housing.

"We're thrilled that he's interested, concerned and will to take the concerns forward," said Wendy Schau of the Halton Town Hall Group (THG).

"This isn't an issue that affects some other group of people out there, it's an issue that affects people we know—our neighbours, our families, ourselves. This isn't something we don't need to be concerned about because it's not relevant to us."

Over the past several months, the group has hosted a series of public meetings to raise awareness of homelessness, has been in contact with area faith groups and approached local government officials.

After receiving the group's comments, the MP said he plans to add his "two cents" and present the information to the federal social policy caucus.

"I think we (federal government) do have a responsibility to make sure it (improvements) happens. If the provinces, in their own wisdom, can't see fit to carry the can, then I think we should," he said.

"Even in an area as wealthy as Halton, there are people who ultimately fall through

the cracks. I think there's a responsibility on the part of all of us to bear our share of supporting people with difficulties."

Among the suggestions Reed will carry forward are increased grant funds, tax reform for rental property purchases/sales and increased tax incentives to own low-cost housing.

"If they were taxed like a small business, their level of taxation would be lower than the level at the moment," said Schau. "Any one of these suggestions would help (reduce) homelessness, not just in Halton, but across Canada."

The recommendations to be presented to Reed are a culmination of reports from the Halton Housing Advisory Committee and the Federation of Canadian Municipalities.
