**NOTICE OF A PUBLIC MEETING**  
**WARD 1 and WARD 2/Part of Lot 29, Concession 4**  
**Elli-Fin Construction, Acton/Esquesing**

General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed nine (9) Lot plan of residential subdivision, plus one (1) retained estate lot, and related amendments to the Zoning By-law 1358, as amended, and Zoning By-law 74-51, as amended, for the Town of Halton Hills. The applications relate to a proposed subdivision, approximately 0.69 hectares (1.697 acres) in size, and a retained estate lot of 8.76 hectares (21.6 acres), being located north of, and abutting 225 Churchill Road (Acton), Part of Lot 29, Concession 4. The property is currently vacant forest, and fronts onto Churchill Road (Third Line).

The proposed Zoning By-Law Amendment to By-law 1358, as amended, would change the zoning on the property from the current "Rural (RU) Zone" (By-law 74-51) to "Holding Residential Sixth Density Special (H-R6-1) Zone" (By-law 1358) to facilitate the development of a nine (9) lot subdivision.

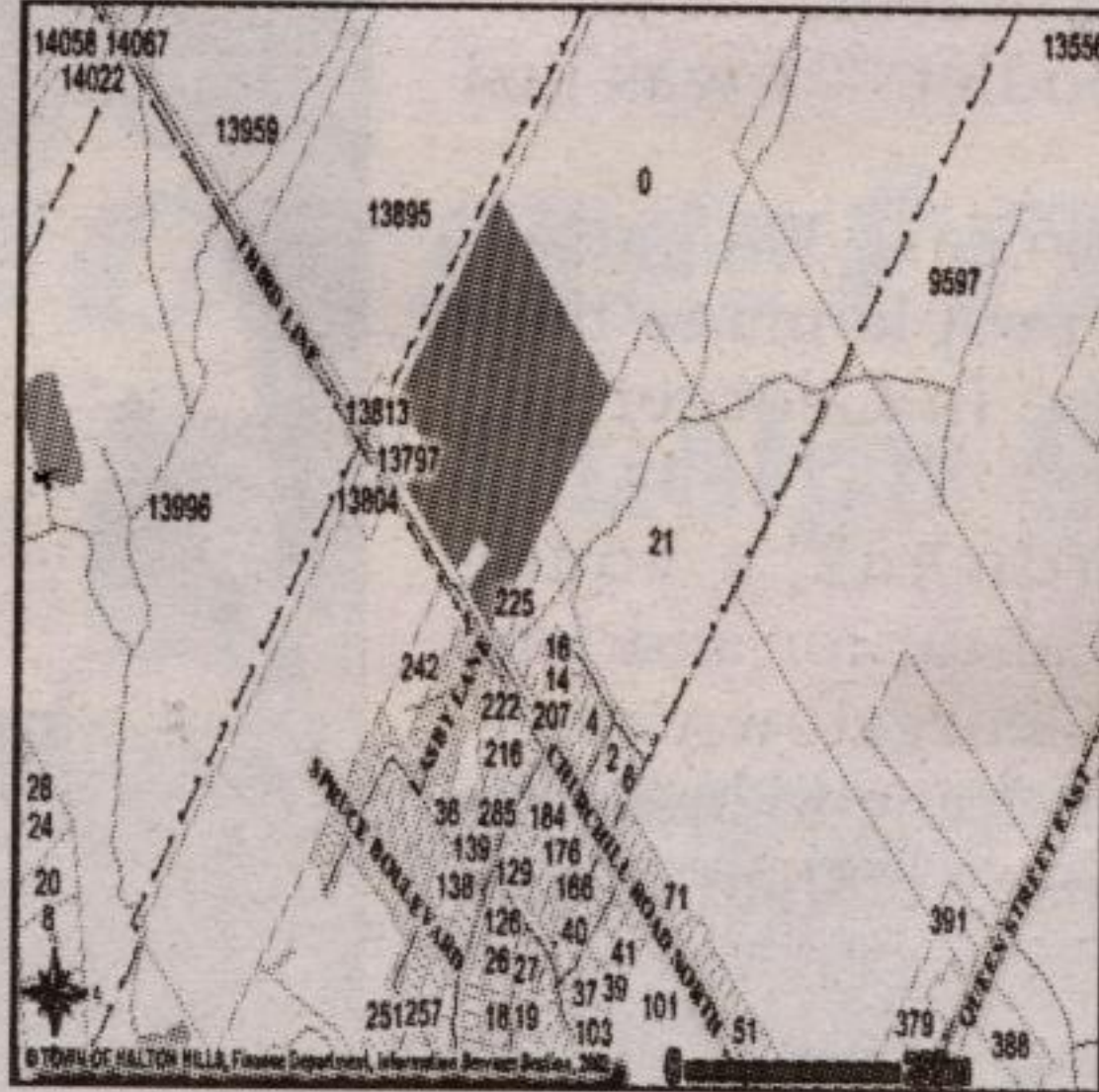
The proposed Zoning By-law Amendment to By-law 74-51, as amended, would change a portion of the retained estate lot from the current "Rural (RU) Zone" to a "Inherent Hazard Lands Special (OS2-1) Zone" to further restrict one (1) currently permitted residential development, and ensure the continued protection of the existing surrounding natural environment.

If you wish to be notified of the adoption of the proposed Subdivision and/or the Zoning By-law Amendments and/or the decision of the Town of Halton Hills in respect of these applications, you must make a written request to the Town of Halton Hills at 1 Halton Hills Drive, P.O. Box 128, Georgetown, Ontario L7G 5G2.

If a person or public body that files an appeal of a decision of the Town of Halton Hills in respect of the proposed subdivision and/or proposed Zoning By-Law

Amendments and does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed subdivision and/or proposed Zoning By-laws are adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

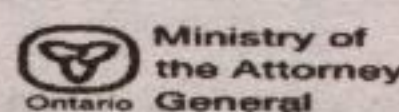

# Hornby abbatoir, owner fined for dumping waste in marsh

**A** local abbatoir and its owner are facing nearly \$50,000 in fines for discharging slaughterhouse waste into a marsh beside East Sixteen Mile Creek.

In Burlington court recently Michael Dorgo, an owner of Town and Country Farms Inc. on Steeles Ave. in Hornby, and the company, pleaded guilty to discharging or permitting the discharge of slaughterhouse waste into the natural environment that caused, or was likely to cause, an adverse effect.

Dorgo was fined \$7,500 plus a 25 per cent victim surcharge, and the company was fined \$40,000 plus a victim surcharge.

Carl Pinto, of the Ministry of the Environment (MOE) Investigations Branch, confirmed the statement of fact presented in court.

He confirmed a former employee at the

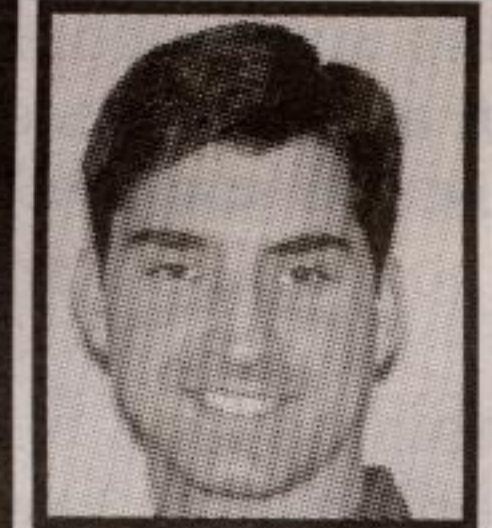
slaughterhouse provided information to the MOE in December 2000 that between March 1995 and October 2000 he was ordered to dump, and witnessed the dumping of, slaughterhouse waste—manure, blood, pig hair, lime and bits of fat from the septic tank in the back of the property to the bank of the ravine/marsh on the shore of the creek.

The employee said he was ordered by Dorgo to run a fire hose from the septic tank to the ravine.

In February 2001 an MOE officer saw a hose imprint in the snow behind Town and Country Farms running from the septic tank to the marsh, and saw pig manure and pig hair at the end of the imprint.

Samples confirmed slaughterhouse waste in the ravine/marsh area.

Charges against Leslie Dorgo and Mario Henry, also officers of the company, were withdrawn.
