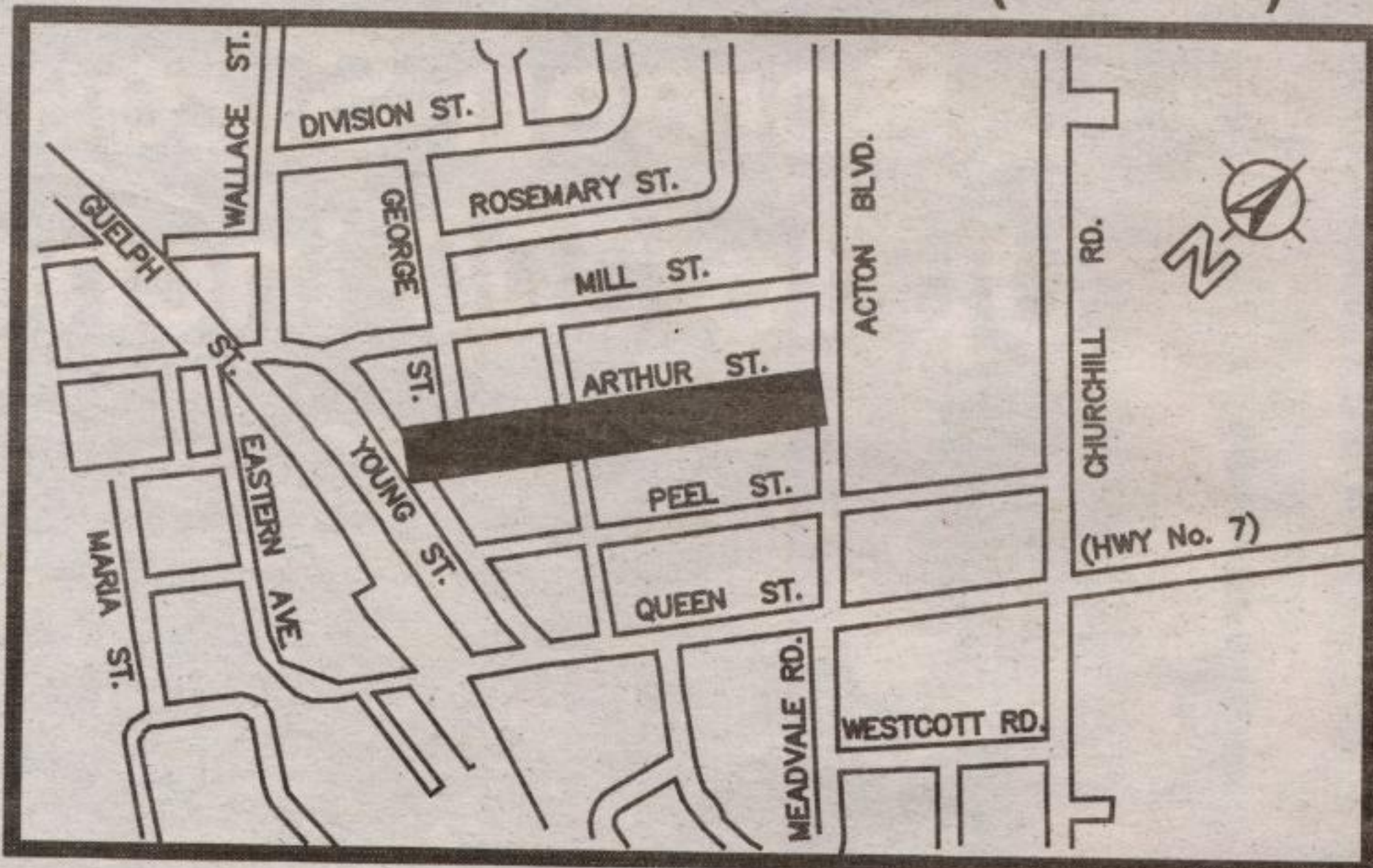

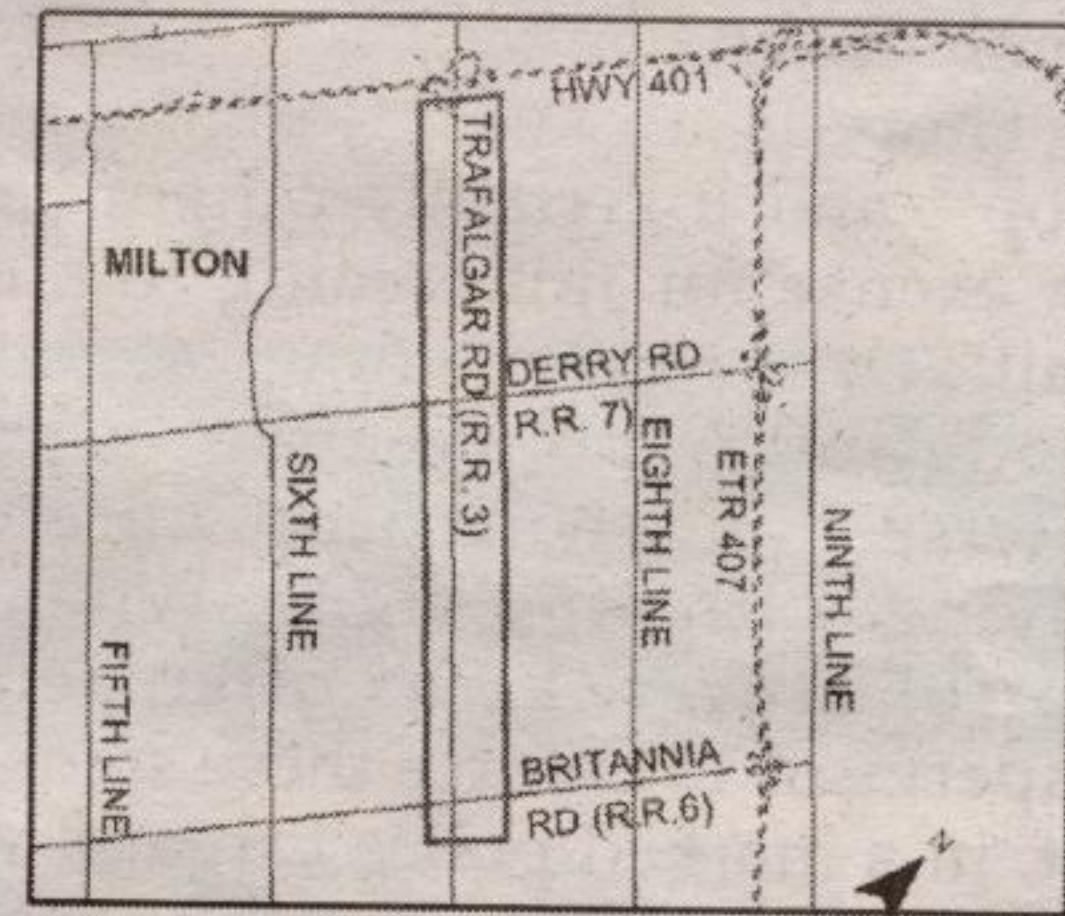

## NOTICE OF STUDY COMPLETION Trafalgar Road (Regional Road 3) Improvements Town of Milton Class Environmental Assessment Study

The Regional Municipality of Halton has completed a Class Environmental Assessment (EA) to consider a wide range of options to satisfy travel demand on Trafalgar Road (Regional Road 3) from Britannia Road north to the south ramp of Highway 401. To best address the operational deficiencies that are currently associated with this segment of Trafalgar Road, a number of road improvement alternatives were examined as part of the study including widening of the roadway, new road alignments, railway crossing options, improvements to intersections and other alternatives.



The study was conducted in compliance with Schedule C of the Municipal Engineers Association *Municipal Class Environmental Assessment (June 2000)*. In accordance with the *Municipal Class EA*, an Environmental Study Report (ESR) was prepared to document the planning and decision-making processes followed. As documented therein, the Preliminary Preferred Design calls for the widening of the approximately 5.1 km segment of Trafalgar Road (RR3) between Britannia Road (RR6) and the south ramp of Highway 401 from two to four lanes (five lanes in some sections) and construction of an overpass at the existing Canadian Pacific Rail crossing.

By this Notice, the ESR is being placed on the public record for a 30-day review period in accordance with the requirements of the *Municipal Class EA*. Subject to comments that were received in response to this Notice, the Region intends to proceed with detailed design and construction of the section of Trafalgar Road (RR3) between Britannia Road (RR25) and the south ramp of Highway 401.

If concerns regarding this Project cannot be resolved through discussions with Regional staff, a person or party may request that the Minister of Environment make an order for the project to comply with Part II of the *Environmental Assessment Act* (referred to as a Part II Order). Requests for a Part II Order must be received by the Minister in writing, at the address provided below by November 25, 2002. A copy of the request must also be sent to the Region's Manager. If no request is received by November 25, 2002, the Region intends to proceed with detailed design and construction.
