our champions. These will be held during the last week of May, 11 a.m. to 2 p.m. each day. Players, watch the boards for your allotted times.

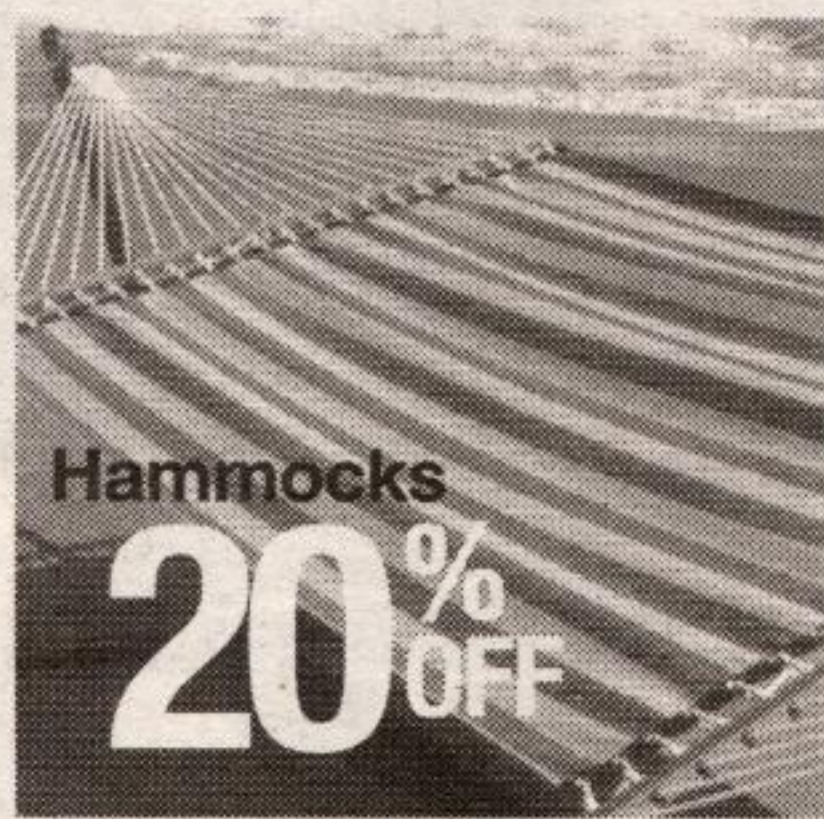

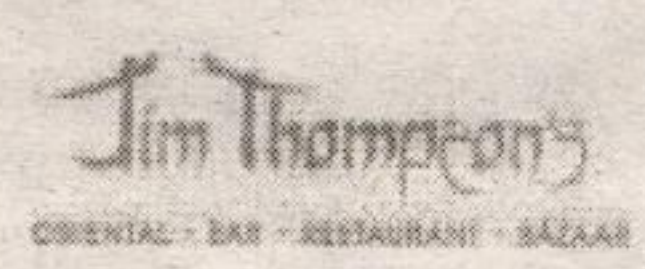

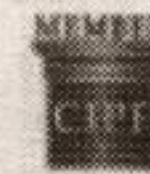
