

NOTICE OF PUBLIC MEETING WARD 1/250-252 Queen Street, Acton Proposed Commercial Building

Town Council for the Town of Halton Hills will conduct a Public Meeting to examine and discuss proposed amendments to the Official Plan and Zoning By-law 1358, as amended. The applications relate to a parcel of land, approximately 1 hectare (2.48 ac) in size, identified as 250-252 Queen Street, Concession 8, West Half of Lot 22. The property is currently vacant land and is adjacent to the LCBO on Queen Street in Acton.


The proposed Local Official Plan Amendment maintains the designation of "Neighbourhood Commercial Area", however it would permit a drug store use.

The proposed Zoning By-Law Amendment would change the current zoning from "Holding Commercial-General Special (H-C1-1) Zone" to "Holding Commercial-General Special (H-C1-2) Zone" to permit among other things as a drug store use.

If you wish to be notified of the adoption of the proposed Official Plan Amendment and/or the Zoning By-Law Amendment and/or the decision of the Town of Halton Hills in respect of these applications, you must make a written request to the Town of Halton Hills at 1 Halton Hills Drive, Georgetown, Ontario, L7G 5G2.

If a person or public body that files a notice of appeal of a decision of the Town of Halton Hills in respect of the proposed Official Plan Amendment does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed Official Plan Amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

If a person or public body that files an appeal of a decision of the Town of Halton Hills in respect of the proposed Zoning By-Law does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed Zoning By-Law is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

The three girls began dancing at an early age and currently study a variety of dance including hip-hop and musical theatre at the Milton school.




