

This is to advise that a Public Meeting will be held to obtain comments on proposed amendments to the Town's User Fees, Licensing Fees and Service Charges on:

#### Monday, September 22nd, 2003 at 7:30 p.m. Council Chambers, **Halton Hills Civic Centre**

The Town of Halton Hills is in the process of undertaking a review of the user fees, licensing fees and service charges for a variety of services and facilities it provides. This is being done under the authority of various pieces of Provincial legislation including the new Municipal Act. A Town of Halton Hills staff report provides a listing of the fees being recommended to Council and will become effective on January 1, 2004. #### **PAYMENT OF TAXES**

#### WHERE?

- Finance Department, Civic Centre (8:30-4:30 Monday to Friday), or
- Any branch of the Canadian Imperial Bank of Commerce located within the Town of Halton Hills (may be subject to a service charge)

#### **AFTER HOURS?**

CIBC branches during scheduled hours of service Drop Box located next to main entrance of Civic Centre available 24 hours

#### HOW? -

- a) By CHEQUE or CASH
- b) POST-DATED cheques are acceptable and will ensure that instalment dates are not missed
- c) INTERAC in person at the Civic Centre d) BY TELEPHONE: At present, the Town has agreements with CIBC, Bank of Montreal, Royal Bank, TD Canada Trust and Bank of Nova Scotia who offer the ratepayer this option (CHECK WITH YOUR BANK FOR FURTHER INFORMATION)
- e) PRE-AUTHORIZED PAYMENT PLAN: For Details, please call Tax Department at 873-2601, ext. 2930.

#### LATE PAYMENTS?

- A late payment charge of 1-1/4 per cent per month will be charged on the first day of each calendar month until taxes are paid.

#### NO TAX BILL?

Bills were mailed June 4, 2003. Failure to receive a Tax Bill does not excuse the Owner from responsibility for payment, nor relieve him/her from liability for late payment charges. Please contact the Finance Department if you did not receive yours.

#### **NEW PROPERTIES?**

- Newly built properties are likely to have tax bills related to their land value assessment only until full assessment is applied and supplementary taxes are billed. Owners are responsible for taxes billed and should make provisions for the future billing of supplementary taxes.

#### **SENIORS TAX GRANT**

- Residents 65 years or older who qualified for this Grant for 2002 will receive this year's application in the mail. Information and new applications are available at the Tax Department.

#### NOTICE OF PASSING OF ZONING BY-LAW **AMENDMENT**

TAKE NOTICE that the Council for the Corporation of the Town of Halton Hills passed By-law No. 2003-0110 on the 8th day of September, 2003 under Section 34 of the Planning Act, R.S.O. 1990, Chapter P.13, as amended.

AND TAKE NOTICE that any person or agency who objects to Zoning By-law No. 2003-0110, may appeal it to the Ontario Municipal Board by filing with the Clerk of the Corporation of the Town of Halton Hills no later than 4:30 p.m. on 9th day of October, 2003 a notice of appeal setting out the objection to the By-law, the reasons to support the objection and a fee of \$125.00 made payable to the Minister of Finance.

Only individuals, corporations or public bodies may appeal a decision of the municipality or planning board to the Ontario Municipal Board. A Notice of Appeal may not be made by an unincorporated association or group. However, a notice of appeal may be made in the name of an individual who is a member of the association or the group on its behalf.

An explanation of the purpose and effect of the Zoning By-law amendment, description of the lands to which they apply is outlined below. A key map showing the location of the lands effected is attached. The complete Zoning By-law Amendment, is available for inspection in the Clerk's Department during regular business hours, Monday through Friday from 8:30 a.m. to 4:30 p.m.
