RESPONSIBILITIES

WARD 2/16406 5 SIDEROAD, HALTON HILLS (ESQUESING) PROPOSED 'VETERINARY CLINIC' USE

Town Council for the Town of Halton Hills will conduct a Public Meeting to examine and discuss proposed amendments to Zoning By-Law 74-51, as amended. The applications relate to a parcel of land, approximately 20.73 ha (51.23 ac) with 309.55m frontage on the southwest side of 5 Side Road (between Winston Churchill Boulevard and Tenth Line) in the Town of Halton Hills (Esquesing).

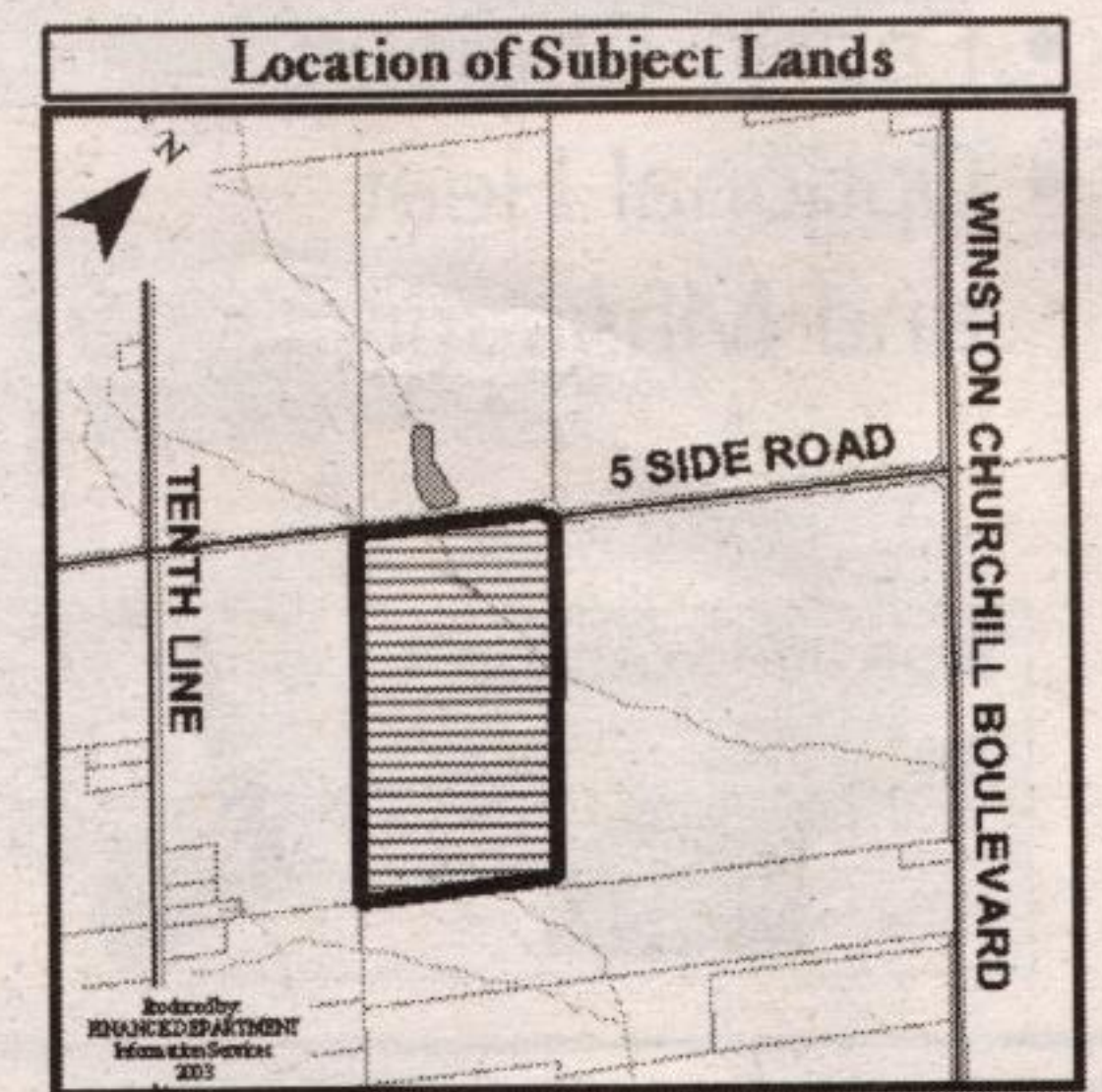
The proposed Zoning By-Law Amendment would change the current zoning from the RU (Rural) Zone, to a new RU-1 (Rural - Special) Zone, to permit among other things a 'Veterinary Clinic' use.
