## NOTICE OF STUDY COMMENCEMENT

Maple Avenue (Regional Road 11) Improvements
Trafalgar Road to Mountainview Road, Town of Halton Hills
(Georgetown)
Class Environmental Assessment Study

The Regional Municipality of Halton, in conjunction with the Town of Halton Hills is initiating a Class Environmental Assessment to rehabilitate the pavement along Maple Avenue (Regional Road 11). (Refer to key plan shown below).

A number of traffic operational and physical improvements will also be considered as part of the Study, some of which include: modifications to existing lane widths and boulevards, new/enhanced centre islands, intersection modifications, new cycling facilities and new/modified road signage. These transportation related improvements will help enhance the safety for drivers, pedestrians and cyclists and longer term traffic needs without compromising the role of Maple Avenue (Regional Road 11) in the road network.

As per the direction of Regional Council, the purpose of the Study will be to recommend improvements that will be implemented within the next few years. It is not the intent of this Study to establish an alternate route for commercial vehicles nor consider a widening to provide additional through lanes as these issues are being addressed through the Region of Halton Transportation Master Plan.

This notice signals the commencement of the Class Environmental Assessment - a study which will define the problem, identify and evaluate alternative solutions, and determine a preferred solution in consultation with regulatory agencies and the public. The study is being conducted in compliance with Schedule B of the Municipal Class Environmental Assessment (June 2000), which is approved under the Ontario Environmental Assessment Act.

A key component of the study will be consultation with interested stakeholders (public and regulatory agencies) at two Public Information Centres (PICs). The PICs will provide stakeholders with an opportunity to meet the Project Team, review the study scope and discuss issues related to the project including alternative solutions, environmental considerations and evaluation criteria. Details regarding the forthcoming PICs will be advertised as the study progresses.


