
Car seat checkup clinic set for fire station tonight

MAINTENANCE CO-ORDINATOR

This hands-on position will see you plan, budget, co-ordinate and implement facility maintenance and repair activities. With at least 3 years of experience in institutional, industrial or facility maintenance and janitorial operations, you have knowledge of all aspects of building, physical plant maintenance and energy conservation. rea parents will have a chance to learn how to keep their children safe while traveling in the car during a free child car seat checkup clinic at the Maple Ave. fire station tonight (Wednesday).

The clinic, hosted by Ray Johnson and Associates Inc. of The Cooperators, will be

held from 5 to 8 p.m.

"Using a child car seat or booster seat is one of the most important things that parents can do to protect their children from injury, but it's not enough to just use a booster or child car seat, you have to use it properly," said Jeanell Vanbesien, a Halton Region public health nurse and member of Halton Partners for Car Seat Safety.

Correctly used child restraints reduce the likelihood of child injury or death during a motor vehicle collision by 75 per cent.

In Canada, four out of every five children are not properly restrained in their car seats. Common mistakes include improper use of the tether strap, failure to use locking clips on seat-belts and improper tightening of seat-belts.


"Booster seats are especially important for children who have outgrown their child car seat, but who are too small to properly use a seat-belt," said Halton Regional Police Services community support officer Const. Laurel Barnett.

"Studies show that booster seats may virtually eliminate the 'seat-belt syndrome' types of injuries seen among children who are involved in a collision and using a seat-

belt before they are ready."

Ontario's Highway Traffic Act currently requires use of child car seats for children up to 40 lbs. (18 kg). The recently defeated Tory government introduced legislation that would require children who weigh 40 to 60 lbs. (18 to 27 kg), and whose seated height is less than 25 inches (63 cm) to use a booster seat while traveling in their parent or legal guardian's vehicle.

Those who attend the clinic should bring their child, the car seat manufacturer's instructions and their vehicle owner's manual. Each safety assessment should take approximately 20 minutes.




