

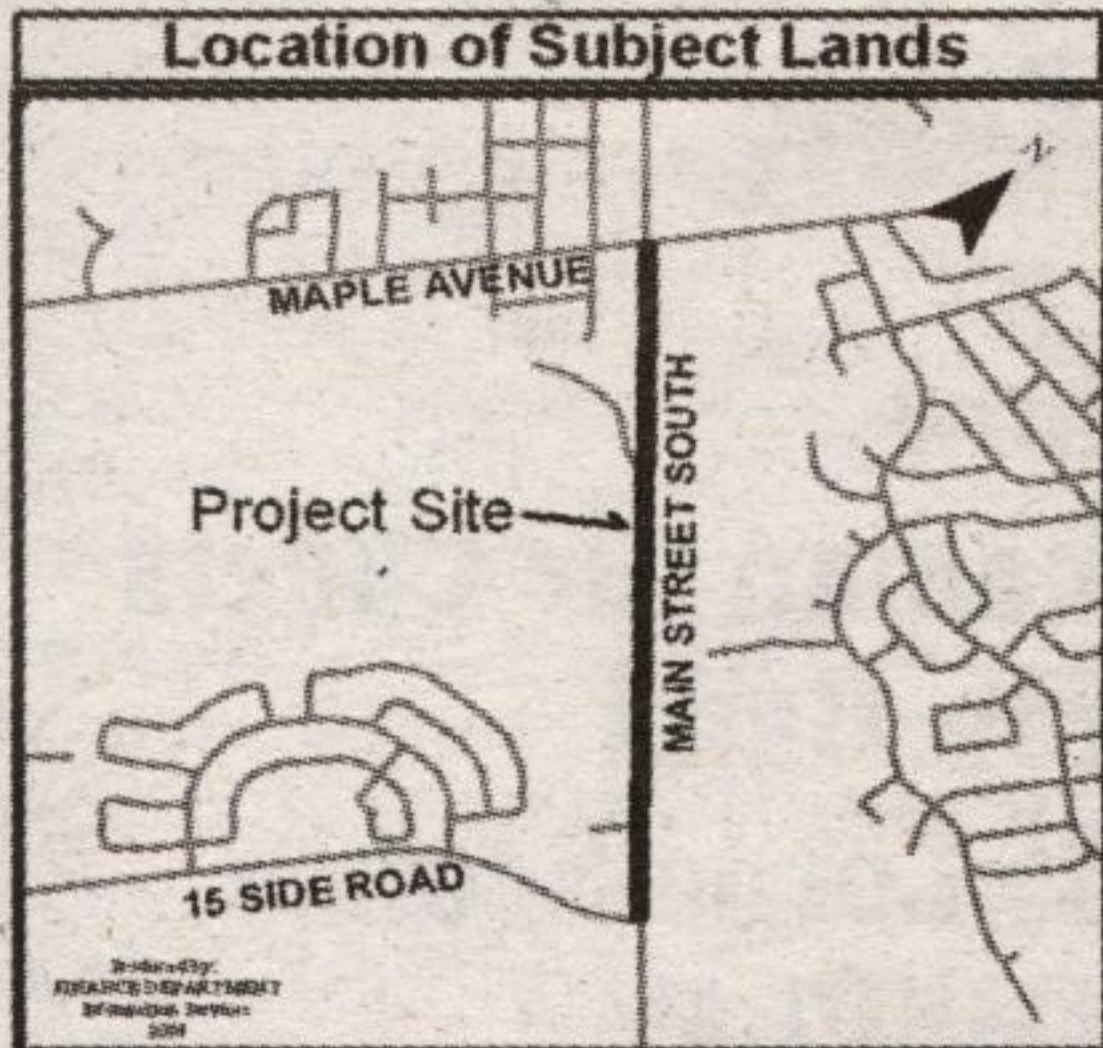

ROAD CLOSURE NOTICE: Main Street South Reconstruction Contract P-2004-C-17

Main Street South will be closed to through traffic from Cindebarke Terrace to 15 Side Road to facilitate the reconstruction of the roadway.



The closure is expected to begin in mid July, 2004 with reopening scheduled for early October, 2004.

The reconstruction of Main Street South will include excavation, new road base, storm sewers, retaining walls, concrete curbing, sidewalks, asphalt and sodded boulevards. In conjunction with the above work, a combination bikeway/walkway, including low level lighting, will be constructed on the east side of Main Street South from 15 Side Road to Maple Avenue. Minor widening of Main Street South, south of Maple Avenue, will also be completed to provide for the relocation to the south of the Cedarvale Park entrance.

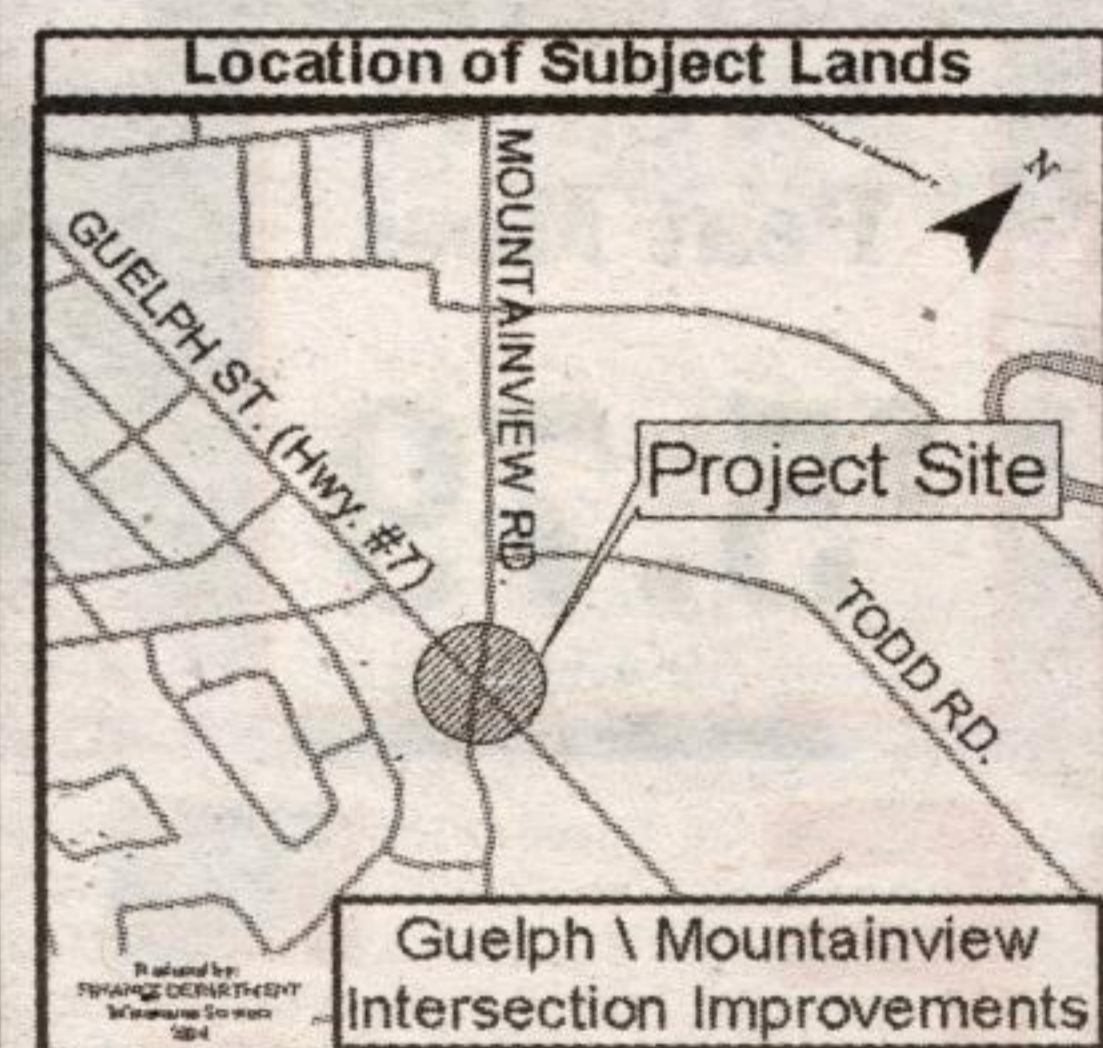

The Town of Halton Hills is proposing to complete improvements to the Guelph Street/Mountainview Road intersection. The improvements include the construction of right turn lanes on Guelph Street, east and west of Mountainview Road and widening of the east side of Mountainview Road, south of Guelph Street.

The improvements will include new concrete islands, curb and gutter, sidewalks, asphalt, line marking, traffic signals and lighting.

This Public Information Centre will provide you with an opportunity to review the project drawings and to discuss the proposed works with representatives from the Town of Halton Hills.

REGARDING A PROPOSED AMENDMENT TO SIGN BY-LAW 2003-0065 AS AMENDED

The Town of Halton Hills is proposing to pass a By-law to amend Town of Halton Hills Sign By-law 2003-0065 as amended, pursuant to the Municipal Act, 2001.

Council at their meeting on April 19, 2004 considered Report No. BLDG 2004-0012 approved the recommendation "that Council adopts the draft amendment to the Sign By-law 2003-0065 as contained in Report No. BLDG 2004-0012 and that staff provides public notice of the Town's intention to pass the draft amendment.

Council is proposing to amend Sign By-law 2003-0065 to permit signs having electronic message centers having stationary illumination of information and changes in not less than 4 hour intervals and a time, date or temperature sign having intermittent information changes in not less than 10 second intervals.

NOTICE OF A PUBLIC MEETING WARD 2 / 8242 Fifth Line (Legendary Motorcar Company) Proposed new policy - to permit historic access/driveway to existing residence.

Town Council for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed amendment to the Town Official Plan. The application relates to a parcel of land known as 8242 Fifth Line (north of Steeles Avenue), identified as, Part of Lot 2, Concession 5. The property is currently used for a house and industrial use (i.e. Legendary Motorcar Company).

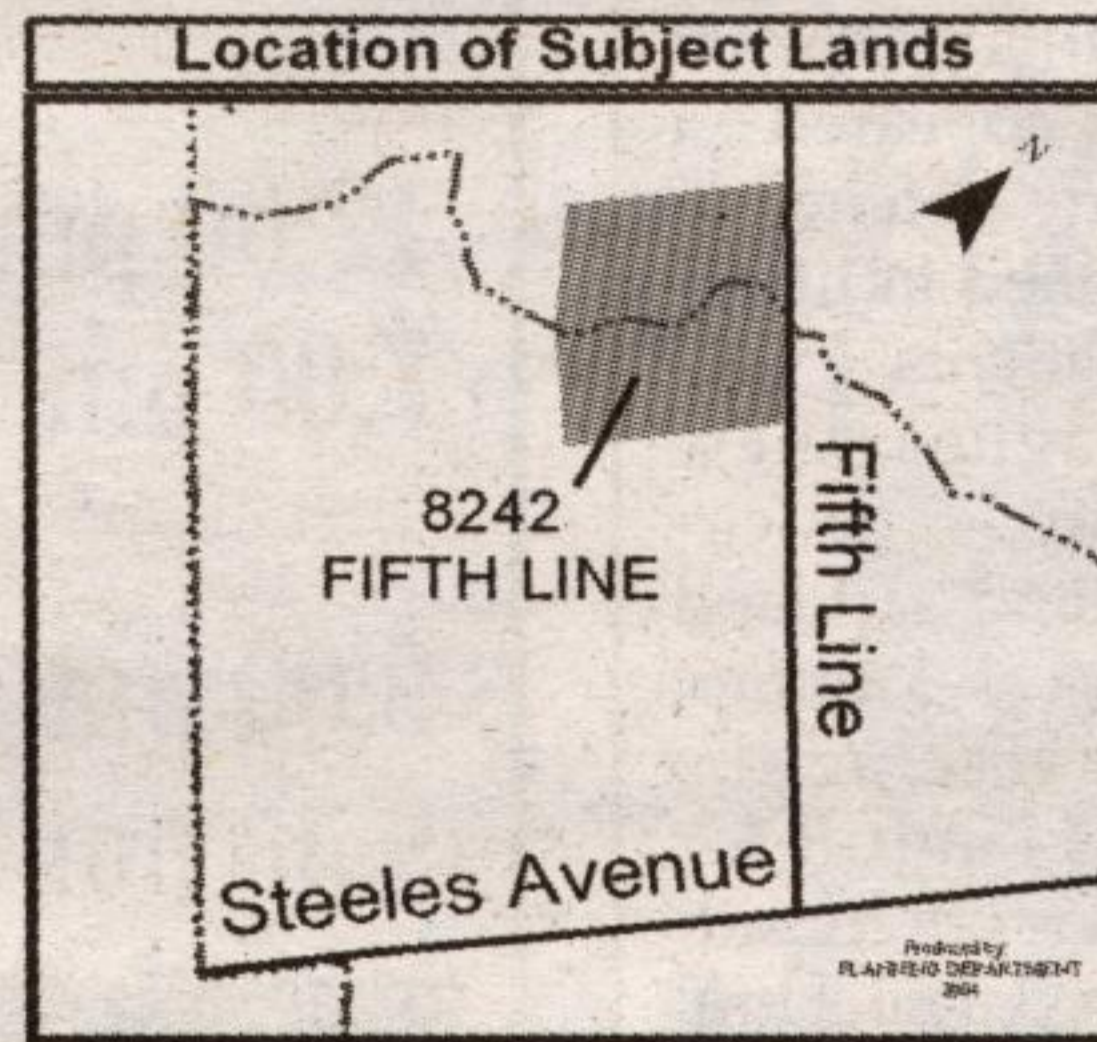
The proposed Local Official Plan Amendment is to introduce a new policy to permit the existing residential driveway to remain open, instead of closing it and creating an access through the 'Legendary Motorcar Company' site, as currently required. The intent is to legalize the existing two (2) accesses from the subject lands, being the Legendary Motorcar Company, and the existing house.

If you wish to be notified of the adoption of the proposed Official Plan Amendment and/or the decision of the Town of Halton Hills in respect of these applications, you must make a written request to the Town of Halton Hills at 1 Halton Hills Drive, Halton Hills, Ontario L7G 5G2.

If a person or public body that files a notice of appeal of a decision of the Town of Halton Hills in respect of the proposed Official Plan Amendment does not make oral submissions at a public meeting or make written submissions to the Town of Halton Hills before the proposed Official Plan Amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

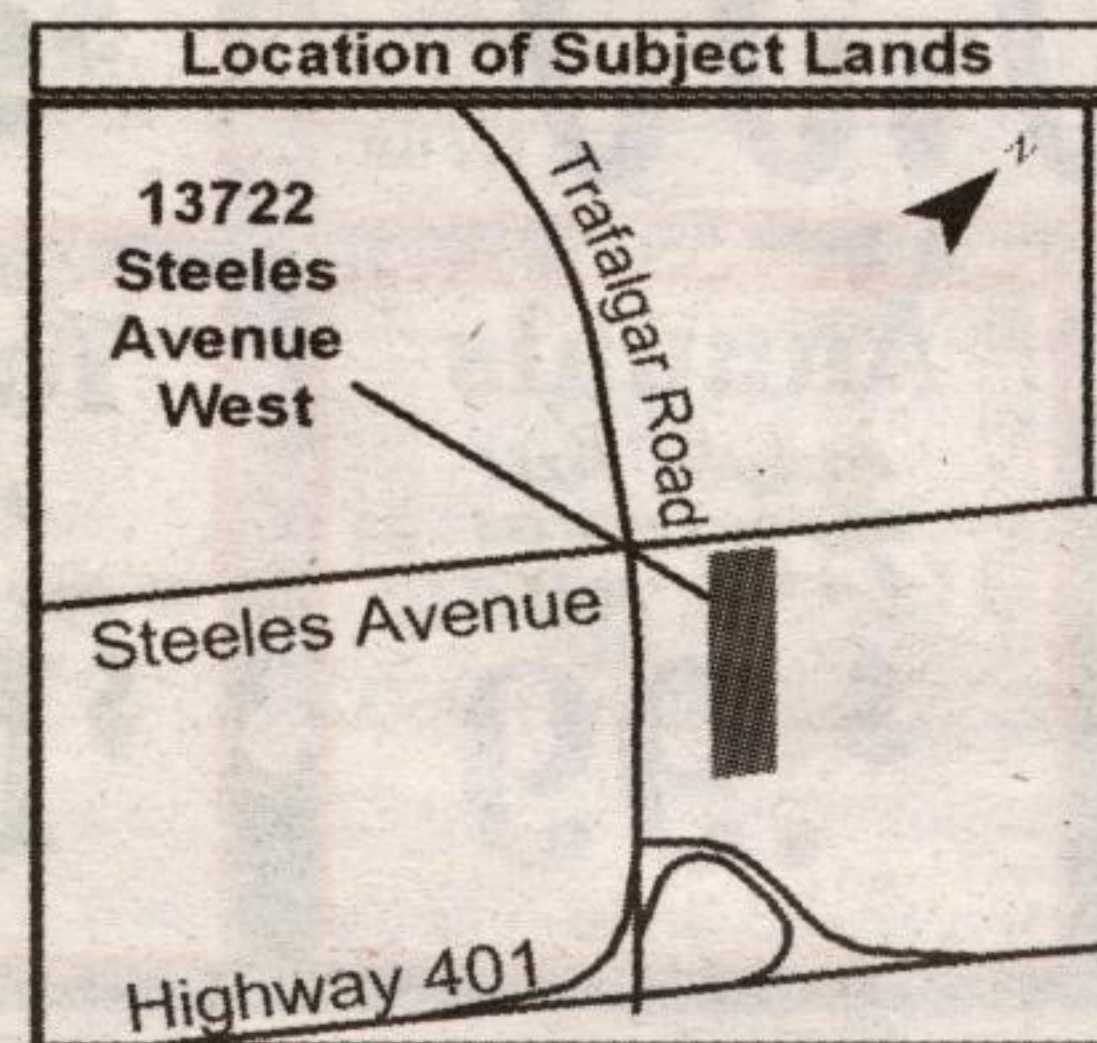
General Committee for the Town of Halton Hills will conduct a Public Meeting to examine and discuss a proposed amendment to Zoning By-Law 57-91, as amended by By-Law 00-138. The application relates to a parcel of land, approximately 1.966 hectare (4.86-acres) in size, identified as 13722 Steeles Avenue West. The property includes an existing residential building, and is bounded by commercial and agricultural uses to the north, commercial and residential uses to the west, agricultural uses to the east, and a MTO parking lot facility to the south.

The property is currently zoned as "401 Corridor (G) Gateway Holding". The "Gateway" zoning permits a wide range of commercial uses. The proposed Zoning By-Law Amendment would maintain the current zoning and would permit the temporary outdoor storage of recreational vehicles in accordance with Section 39 of the Planning Act.

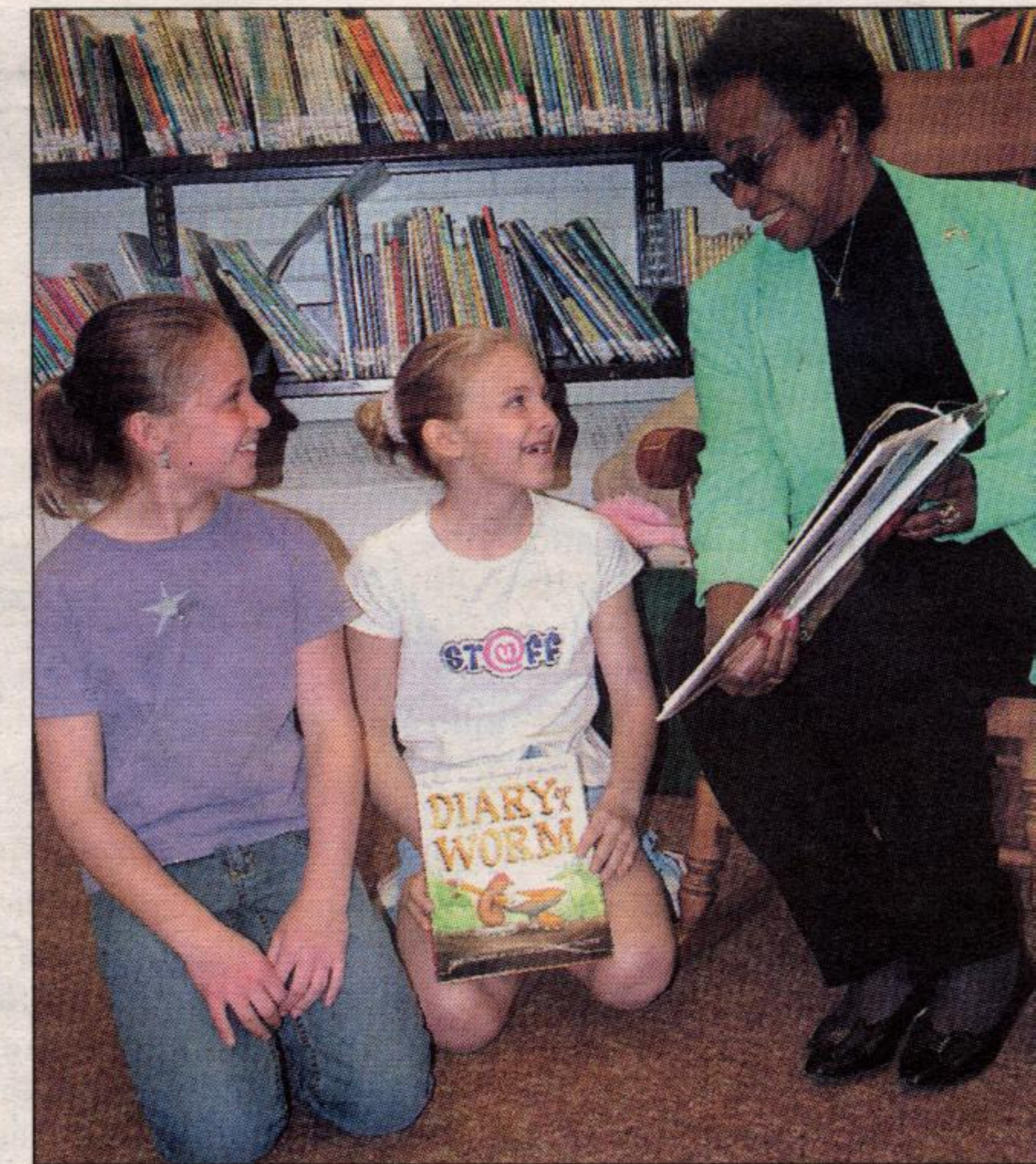
