# New high school opens today

More than 100 students have registered for Georgetown's Gary Allan High School, which is holding its official opening today (Wednesday) from 10:30 a.m. to 7 p.m.

The high school, located at 96 Guelph Street, is now home to five of the Halton District School Board's many alternative education programs. They include morning and afternoon programs for the Secondary Teen Education Program (STEP), which provides high school programs for students who have difficulty succeeding in larger secondary school settings. The Teen Education and Motherhood Program (TEAM) not only helps young moms achieve their high school diploma, but provides daycare and support as well. In addition, Gary Allan offers Adult High School, famous for its flexible learning styles and co-operative education, which allows its students education in either teacher-led traditional classrooms or independent self-reliant

learning—a must for people who cannot attend regular day classes because of work or family commitments.

Visitors to the Open House will also be able to see SCORE classes (programs for 14 to 16-year-olds in an alternative setting), visit Ontario Early Years, and meet English as a Second Language and Halton Literacy Council representatives.

Principal Karen Gill and assistant director of education Barry Finlay will be on hand from 12:30 p.m. to 1:30 p.m. to make a formal presentation and talk to visitors.

The high school is named for the late Gary Allan, a teacher who spearheaded alternative education for this region. Allan left staff and students with the lasting motto which guides the high school named after him: "Whatever it takes!"

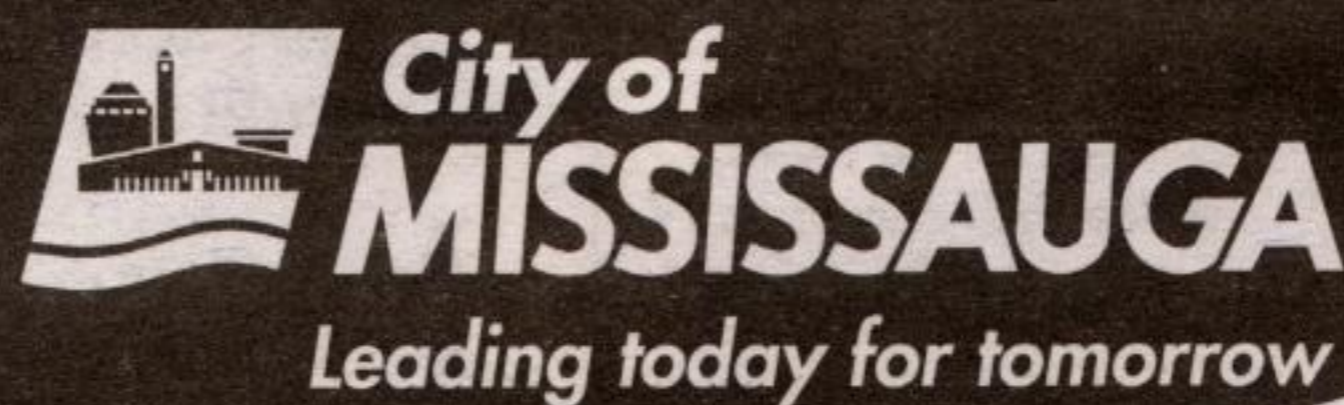

### BY-LAW NOTICE

PLANNING ACT

NOTICE OF THE PASSING

OF ZONING BY-LAW  
BY

THE CORPORATION OF THE CITY OF MISSISSAUGA

TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed By-law 0412-2004, on the 29<sup>th</sup> day of September, 2004, under Section 34 of the Planning Act R.S.O., 1990,c.P.13, as amended.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the By-law by filing with the Clerk of the City of Mississauga not later than the 26<sup>th</sup> day of October, 2004, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection.

Only individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

#### Explanation of the purpose and effect of the by-laws:

The purpose of this By-law is to permit motor vehicle rental facilities within the "CC1" and "CC2" zones within the City Centre. Amendments are required to the zoning by-law 5500 to bring it into conformity with Mississauga Plan. The subject lands are located within the City Centre Planning District

This By-law does the following:

- Amends the definition for "Public Garage" by removing the reference to hire in subsection 2(88);
- Adds a definition for Motor Vehicle Rental Facility;
- Permits motor vehicle rental facilities in the "CC1 and "CC2" zones
- Adds regulations to the Standards for Development sections of the "CC1" and "CC2" zones for motor vehicle rental facilities as follows:

- Motor vehicles offered for rent or lease shall not be parked or stored on required parking;
- There shall be no motor vehicles having a vehicle weight over 2300Kg (5,070lb.) being offered for rental or lease.

The lands to which the proposed Zoning By-law applies is subject under the *Planning Act* to an Official Plan Amendment. The By-law will not come into effect until Mississauga Plan Amendment 23, is in force.
