I have been having right hip and knee problems. My •physiotherapist has told me that I overpronate at my feet and orthotics would help correct this. Is it possible that poor foot biomechanics can cause hip and knee pain?

. Your body is all part of one kinetic chain. The foot is the most • important link within the kinetic chain, since it is the first part to hit the ground as you walk. In general, your foot motion can be described as normal, overpronated or oversupinated. Imbalances with the chain can have effects as high as the neck region.

For overpromators, the purpose of orthotics is to maintain the foot ina "neutral" position. for oversupinators, the purpose is for the orthotic to absorb some of the ground forces, since a supinated foot is a "locked and rigid foot."

How your feet react with the ground determines how the rest of your body reacts as well. In a normal kinetic chain, muscles must contract against the forces generated by abnormal foot biomechanics. This leads to muscles and tendons having to work improperly. As a result, they eventually fatigue and breakdown. When the muscles and tendons cannot work properly, they are unable to keep joints in alignment. This can have effects throughout the body. More prevalent however, are problems closer to the feet such as in your case, the knees and hips.

You orthotics are transferable between shoes. They may take a few days to get used to, but will play a great roll in decreasing your symptoms.

When Linda came to the office we reviewed her past medical history, and physical complaints, as well as mental and emotional stressors, preferences, fears, thought and behaviour patterns etc.

*Based on this whole-health picture, I recommend a specific homeopathic remedy which best addressed her overall health issues - tired, frazzled, low libido, hot flashes, a little angry, even her chocolate cravings. Within an hour of taking the remedy she started to feel (in her words) "different". her system had been stimulated to start the rebalancing process.

*For nutritional support I suggested reducing coffee; substituting good fast for bad (eg. using extra virgin olive oil vs partially hydrogenated vegetable oil); increasing her green leafy vegetable intake; and optimizing her anti-oxydant profile - Vit. A, C, E, Selenium, etc.

*For exercise she liked walking; and I shared a simple but effective relaxation technique, so that in just 15 minutes she could feel calm and centered

*In three months, her hot flashes were 80% improved; she felt her old easygoing self again, was better able to handle all the stressors in her life; and the relationship with her partner was better too.



: I am interested in making wine at a wine on premise store. I know I'll save money, but I am concerned about the quality of the wine. Is it as good as what I can buy at the liquor store?

: The answer to your question is Yes! The quality is as good as most A popular wines from the liquor store, although the comparison can only be done after the wine has been cellared for a few months. The ingredients used at a wine on premise store come from the same vineyards that commercial wineries use. However, wine that is purchased from the liquor store has been in the bottle for at least 6 months before being shipped and therefore has had time to mature. In fact, most of the world's wine is consumed between one and two years after it was made. The wine you make at a wine on premise store is young, so it's important to give it some time after you bottle it to appreciate its taste, body and unique


In the past, there were issues with the quality of self made wine and this had to do largely with the quality of the kits comprised mostly of generic concentrates. In recent years, the biggest wine producers in Canada have been involved in producing kits and the quality has improved dramatically. New innovations, such as the addition of crushed grape skin packs to kits have elevated the quality even further.
