## NOTICE OF PUBLIC OPEN HOUSE

### You are invited to attend a Public Open House on the Halton Regional Forests Draft Management Plan

Halton Region owns 1645 acres of significant forests in the Towns of Milton and Halton Hills, which were known as the Agreement Forests and managed by the Ministry of Natural Resources on behalf of Halton Region until 1995. Recognizing the importance of these forests as a major public trust and environmental asset, Regional Council directed staff to undertake the preparation of a management plan for the long term protection and management of these forests. A draft of the management plan is now available for public review and input. The plan addresses the environmental sensitivity as well as the recreational, educational and forestry potential of the forests. There are many existing activities in the forests and the draft plan makes recommendations on balancing the preservation and public access of this valuable resource.

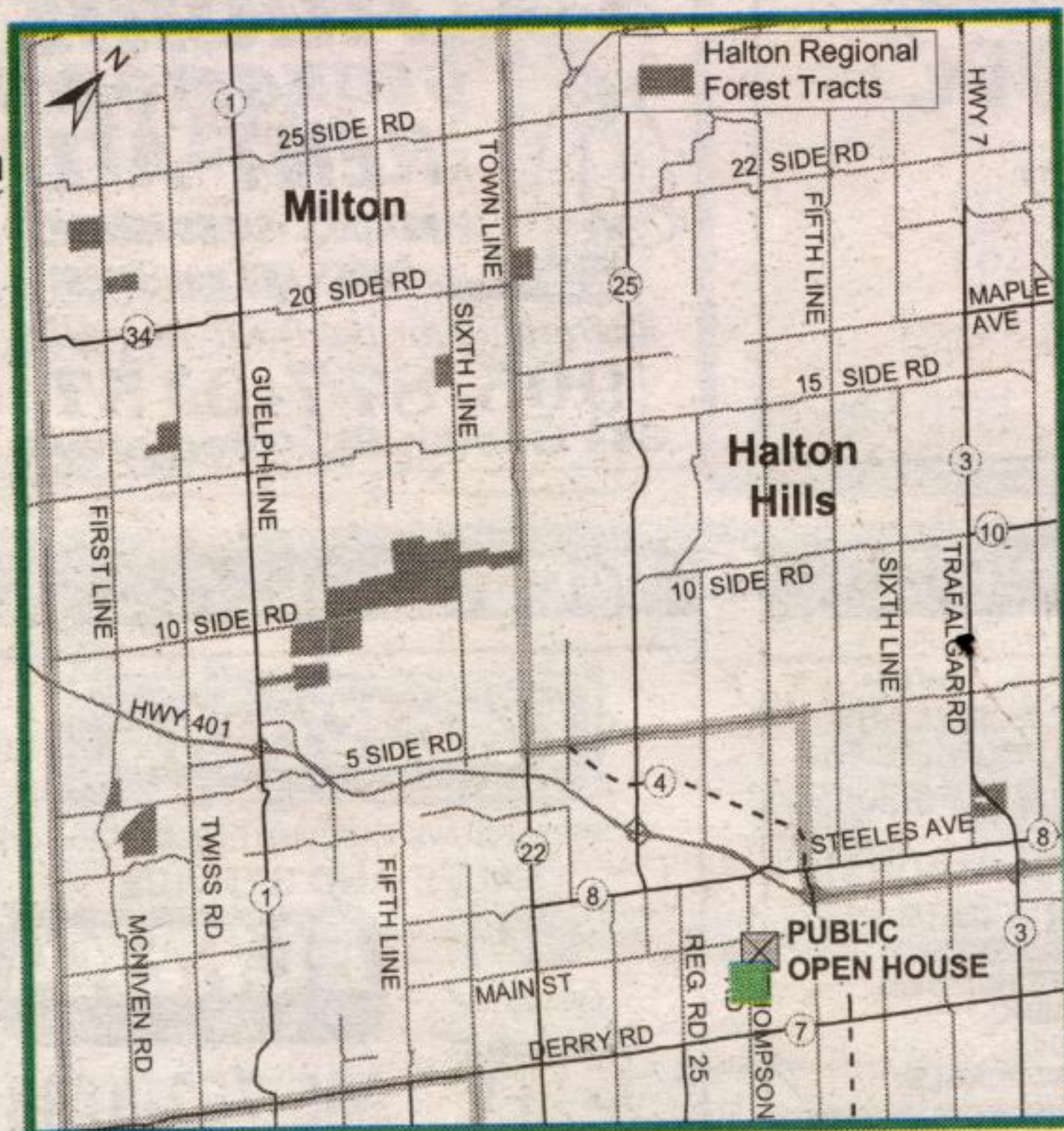

## NOTICE OF COMPLETION

### Georgetown Urban Area Water Supply - Lindsay Court Well Supply Expansion

On June 13, 2003, the Regional Municipality of Halton published a Notice of Completion of the Georgetown Water Supply Master Plan Review.

Through the Master Plan Review, it was determined that the preferred method of supplying municipal water to approved and planned growth in the Georgetown Urban Area was groundwater based and consisted of upgrading the existing water system and reducing current and future water demand.

One of the projects identified was the expansion of the existing Lindsay Court Well Supply to increase the average pumping on a daily basis. On June 24, 2004, the Ministry of Environment issued a revised Permit to Take Water to allow for an increase in the average daily pumping from 4,000 m<sup>3</sup>/d to 6,050 m<sup>3</sup>/d. The Region of Halton has continued in discussions with the Ministry of Environment and the Credit Valley Conservation Authority to explore the feasibility of increasing the pumping a further 495 m<sup>3</sup>/d to allow for average daily pumping of 6,545 m<sup>3</sup>/d and is now issuing a Notice Of Completion of the Class Environmental Assessment requirements for this undertaking.

This project to rerate the average daily pumping capacity at Lindsay Court is being planned under Schedule B of the Municipal Class Environmental Assessment (June, 2000) and subject to comments received as a result of this Notice, the Region of Halton intends to proceed with the implementation of this project by applying to the Ministry of Environment for a revision to the Permit to Take Water to allow for the increased pumping.

The Project File on this project is available for public comment at the Halton Region Citizen's Reference Library at 1151 Bronte Road, Oakville or by contacting the Manager of Infrastructure Planning at the address below.

Interested parties should provide written comment to Halton Region on the proposal within 30 calendar days from the date of this Notice. Comment should be directed to the Manager of Infrastructure Planning.

If concerns arise regarding this project, which cannot be resolved in discussion with Halton Region, a person or party may request that the Minister of Environment make an order for the project to comply with Part II of the Environmental Assessment Act (referred to as a Part II order), which addresses individual environmental assessments. Requests must be received by the Minister at the address listed below within 30 calendar days of this Notice. A copy of the request must also be sent to the Manager of Infrastructure Planning. If there is no request received by December 6, 2004, the Region will proceed with the application to increase average daily pumping capacity at Lindsay Court.

### Blue Box Recycling Tips

You can help reduce litter with some simple steps to prevent your recyclables from taking flight on windy days. Please ensure your blue box materials are placed curbside in a secure manner.

- On windy days, place your blue boxes out for collection on the morning of collection day, by 7:00 a.m., instead of the night before.
- If possible, stack your blue boxes on top of one another to prevent papers from blowing away.
- Fill boxboard boxes with other boxboard material.
- Place heavier items on top of lighter items.
- Flatten and tie large cardboard boxes and place securely underneath or between your recycling boxes.
