

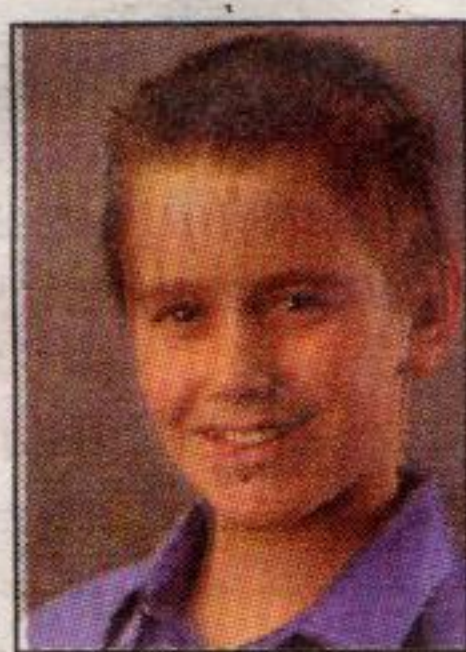

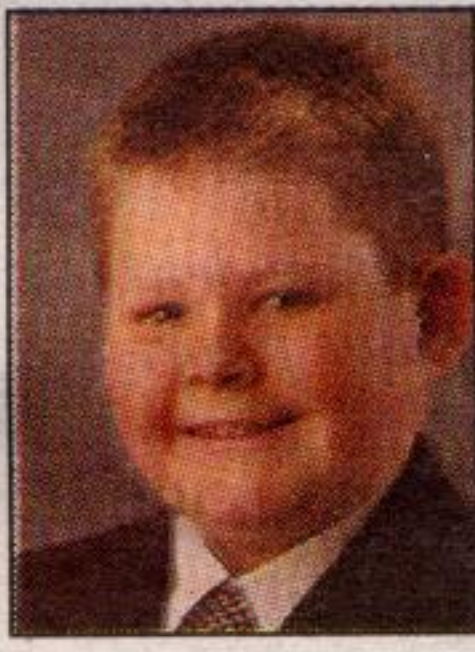

Pineview



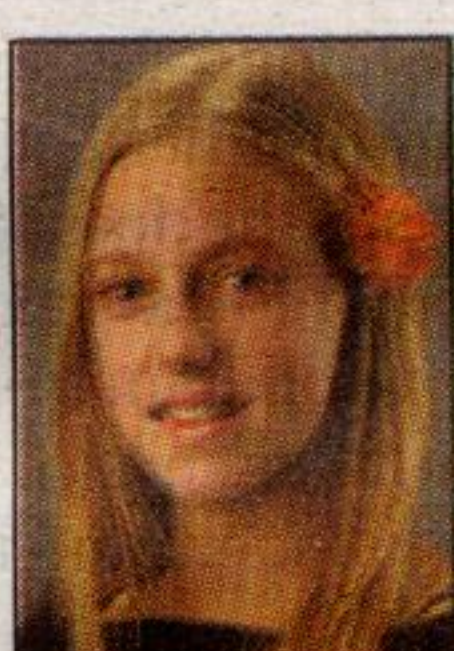

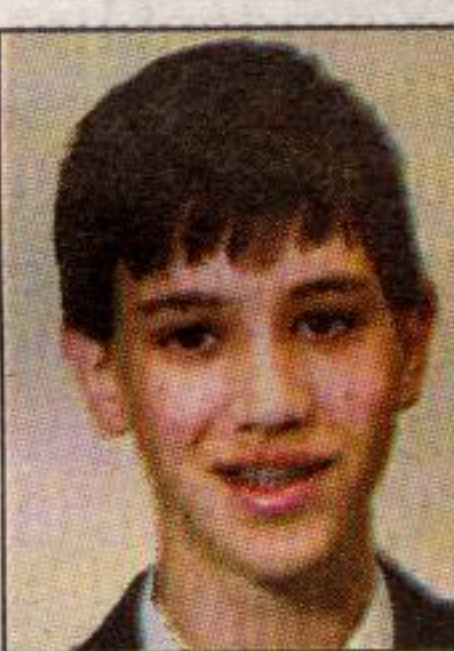
Patrick Byrne

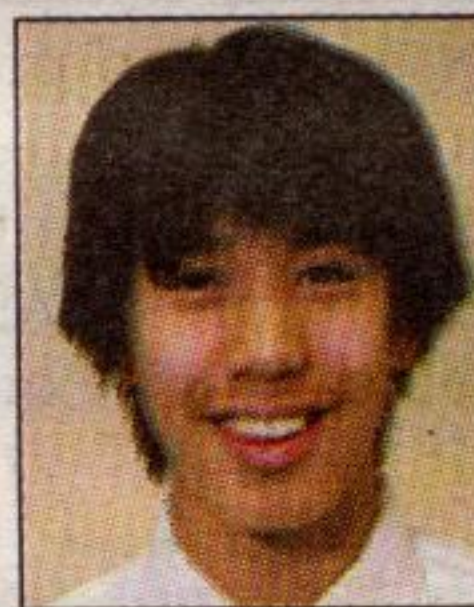
Jason Pires
