A Community Update regarding the Georgetown Hospital Transfer

In June 2005 William Osler Health Centre and Halton Healthcare Services published a joint letter informing the community of the upcoming transfer of the Georgetown Hospital to align with health care planning for the redefined Mississauga-Halton Local Health Integration Network (LHIN).

Since that time a transition team, comprised of representatives from both hospital organizations and the Ministry of Health and Long-Term Care, has been working to ensure the interests of our patients, health care teams and hospitals are addressed.

The target date for the Georgetown Hospital transfer from William Osler Health Centre to Halton Healthcare Services is early January 2006.

Patient care comes first and foremost at William Osler Health Centre and Halton Healthcare Services. Both hospital organizations are committed to ensuring a seamless transition without disruption of patient services.

Patients wishing to access programs and services at Halton Healthcare Services' hospitals in Oakville or Milton or at William Osler Health Centre's hospitals in Brampton (Peel Memorial) or Etobicoke may continue to do so through physician referrals.

We ask for your patience and co-operation as our transition team completes its work to make this transfer as smooth as possible for patients, physicians, staff and volunteers.

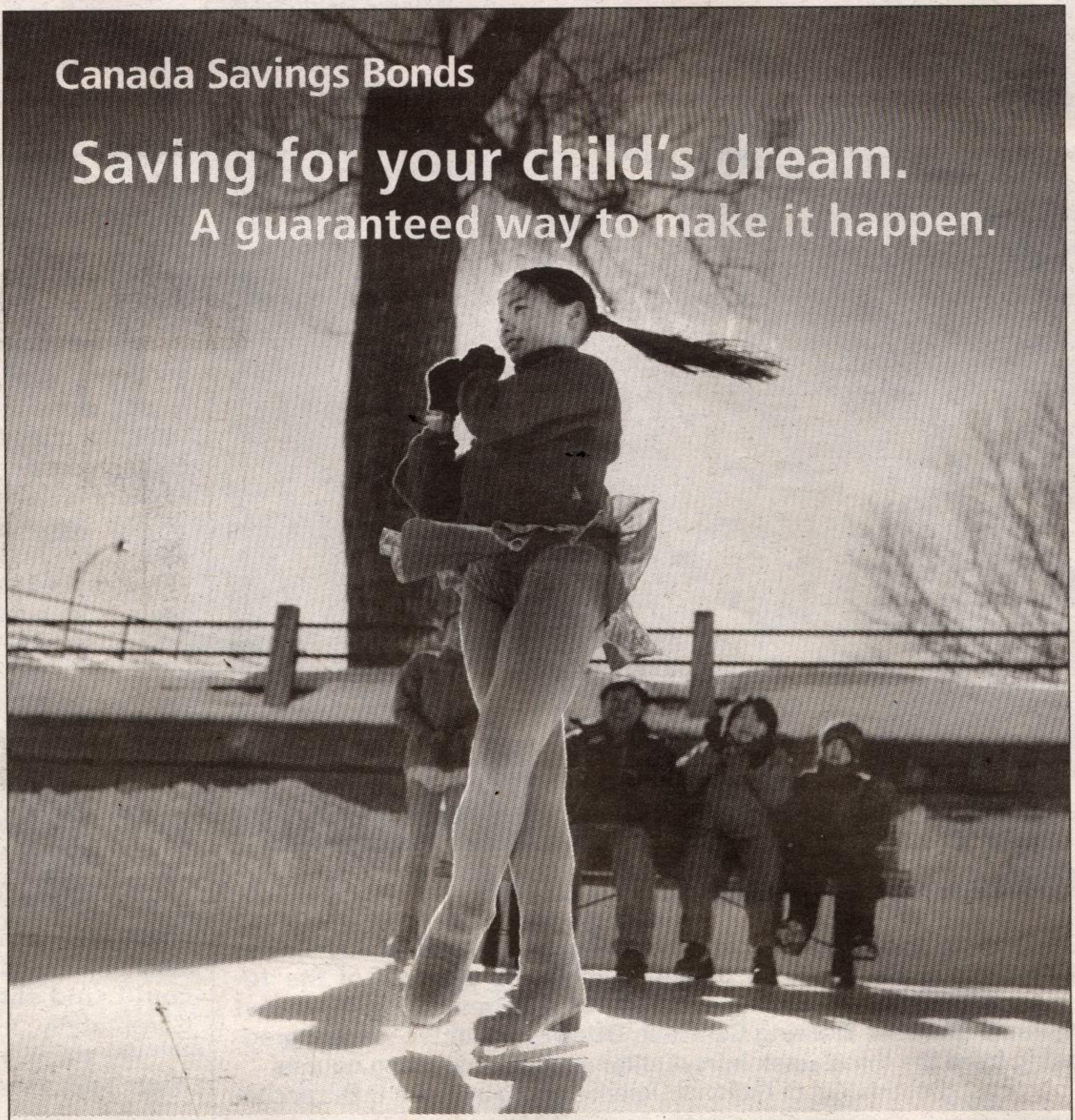
Charged is Blaise Chiasson, 53, of Arthur St.
