NOTICE OF PUBLIC INFORMATION CENTRE #1

Steeles Avenue (Regional Road 8) Transportation Corridor Improvements James Snow Parkway (Regional Road 4) to 250 metres West of Trafalgar Road (Regional Road 3), Town of Halton Hills Class Environmental Assessment Study

The Regional Municipality of Halton is carrying out a Class Environmental Assessment to consider a wide range of options for transportation corridor improvements to satisfy future travel demands on Steeles Avenue (Regional Road 8) from James Snow Parkway (Regional Road 4) to 250 metres west of Trafalgar Road (Regional Road 3), in the Town of Halton Hills (see map below). In order to best address operational deficiencies along the Steeles Avenue corridor, a number of road improvement alternatives will be examined as part of the study including widening of the roadway, cross-sectional elements, intersection improvements, over all traffic operations, as well as the impact of such improvements on the social and natural environments. The study is being conducted in compliance with Schedule C of the Municipal Class Environmental Assessment (June 2000), which is approved under the Ontario Environmental Assessment Act.

A key component of the study will be consultation with interested stakeholders (public and regulatory agencies) at two Public Information Centres. The first Public Information Centre has been arranged for:



Following the Information Centre, the study findings will be reviewed in light of comments received and the preferred alternative will be determined. PUBLIC COMMENT INVITED

Cedarvale Well Field Expansion Class Environmental Assessment Study Georgetown Water Supply System **Town of Halton Hills**

The Regional Municipality of Halton has initiated a Class Environmental Assessment to supply Georgetown with additional water from the Cedarvale municipal water supply well field. The expansion of the existing Cedarvale well field to supply water to current residents and for new planned growth in Georgetown was identified as a preferred option in the Georgetown Water Supply Master Plan Review (Halton Region, 2003). This project is being conducted in accordance with the requirements of Schedule B under the Municipal Class Environment Assessment (June 2000), which is approved under the Ontario Environmental Assessment Act.

From 2003 to 2005, and in consultation with the Ministry of the Environment (MOE), Credit Valley Conservation (CVC) and the Ministry of Natural Resources (MNR), the Region completed an ecological monitoring program and a groundwater assessment of the Cedarvale well field to confirm the technical feasibility of this preferred option.

Public consultation is a key component of this project. Halton Region is interested in any comments that you may have concerning this project and will receive comments in writing until December 19, 2005. Subject to comments received from review agencies, the public and the receipt of necessary approvals, the Cedarvale well field expansion is planned to start in the spring of 2006.
