Purse containing diamond necklace stolen

Halton Police are investigating the theft of a purse containing a diamond necklace and cell phone from Boston Pizza on December 22. The incident was only recently reported to police.

The white gold necklace (twisted roped style chain) with a single diamond is valued at approximately \$700.

Halton Police report three plastic-coated metal bench seats valued at \$900 were taken from outside of Ecole Sacré Coeur on Miller Dr. sometime between last Tuesday and Friday. Bolts were taken out to

remove the 10 ft. by 2 ft. seats.
