Spotlight on Volunteer

When one thinks about Junior Achievement in Halton Hills, the first name that comes to mind at our Chamber is Jamie Schumacker. It comes as no surprise, as Jamie has been involved with JA activities for the past 25 years.

Jamie's encounter with JA began as a student participating in a high school program in Sudbury. The experience there gave him an appreciation of the business world and motivated him not only to continue his education but also to start his own business. During his third year at Laurentian University, Jamie started a management consulting firm which he ran for another two years after graduation in 1988. Since then, he has served as the Chair of the Board of JA in Ottawa-Carleton, Burlington and Halton. Through this tenure, Jamie was also a director on the board of Junior Achievement of Canada. He is committed to work with the youth in our community and the next generation of business leaders to "give back to the community," a comment often heard from our volunteers.

Jamie moved to Georgetown with his wife Cydney in 1996 and a close relationship with the Chamber developed at that time. In 2003, he became a Chamber member.

In addition to these efforts, Jamie also volunteers in the classrooms, delivering at least two in-school programs per year. JA programs consist of two types: an after-school program where high school students create their own company under the direction of volunteer business advisors, and several in-school programs from Grades 3 - 12 covering various business topics. JA programs were delivered to over 1,000 students in Halton Hills last year.

The programs are offered free of charge to students and are funded by local businesses in the form of corporate sponsorships. The cost per student to participate in an in-school program is \$20, a modest sum in itself, but with 1,000 students involved annually, funding continues to be a challenge.

This past year, Jamie experienced his biggest challenge (and achievement) yet, when he was able to keep the JA program running in Halton Hills despite JA South Central Ontario ceasing operations in June. "Without the Chamber's support," he stresses, "and their commitment to put an agreement in place with JA Canada and JA London, these programs would not have been available this year in Halton Hills." When he became a Director of the Chamber in September, he formed and chairs the Junior Achievement Committee whose responsibility now includes program delivery in Halton Hills.

Other volunteer activities include work for many charitable organizations, which include the Juvenile Ride for Diabetes, canvassing for the Heart and Stroke Foundation and participating in a number of United Way events.

Spare time? Jamie enjoys being with his wife and three children and being a part of their after-school activities. These days, that includes getting them out to the slopes for down-hill skiing. The key thing that keeps Jamie going is the support of his family, and he is very conscious and appreciative of this support.




