NOTICE OF MEETING

You are invited to attend a Public Information Meeting to be held by the Council of the Corporation of the Town of Caledon to consider a proposed Official Plan Amendment and a Zoning By-Law Amendment.

In October 2000, the Town of Caledon adopted amendments to its Official Plan and Zoning By-law 87-250 to implement the Region of Peel's Wellhead Protection Program. The purpose of the Wellhead Protection Program is to protect municipal drinking water supplies by regulating specific land uses within defined Wellhead Protection Areas around municipal wells servicing the Region's ground-water based water supply system in Caledon.

Since 2000, the Region has constructed four additional municipal wells and decommissioned nine. The Region has requested the Town amend its Official Plan and Zoning By-law to reflect these changes to the Region's groundwater supply. The proposed Official Plan and Zoning By-law amendments are straightforward and technical in nature. The Town is proposing to modify Schedule "O" (Town of Caledon Wellhead Protection Areas) of its Official Plan and the appropriate Schedule A Zone Maps.

The purpose of the Public Meeting is to provide information to Caledon residents, landowners and other interested parties about the proposed Technical Update to Wellhead Protection Areas within the Town of Caledon, and to provide an opportunity for input.

ADDITIONAL INFORMATION

If a person or public body that files an appeal of a decision with respect of the proposed Wellhead Protection Technical Update does not make oral submissions at the public meeting, or make written submissions to the Town of Caledon before the proposed by-law is approved or refused, the Ontario Municipal Board may dismiss all or part of the appeal.

If you wish to be notified of the adoption of the proposed Official Plan and Zoning By-law Amendments you must make a written request to the Town of Caledon, Planning and Development Department, 6311 Old Church Road, Caledon, Ontario L7C 1J6.

If a person or public body that files a notice of appeal of a decision of the Town of Caledon in respect of the proposed Official Plan and Zoning By-law Amendments does not make oral submissions at a public meeting or make written submissions to the Town of Caledon before the adoption of the proposed Amendments, the Ontario Municipal Board may dismiss all or part of the appeal.

A copy of the proposed Official Plan and Zoning By-law Amendments will be available to the public for inspection 20 days prior to the meeting in the Planning and Development Department. Office hours are Monday to Friday from 9:00 a.m. to 4:30 p.m. Written submissions may be mailed or personally delivered to the Planning and Development Department at the above noted address.

It should be noted that the new well and associated Wellhead Protection Area in the vicinity of Palgrave is within the Oak Ridges Moraine Conservation Plan Area. As a result, the Minister of Municipal Affairs and Housing is the approval authority for the proposed revisions in this area. The proposed Official Plan and Zoning By-law amendments are not subject to Section 17(36) of the Planning Act.
