

# Crop for Cancer is 12-hour marathon scrapbooking event

For the fourth year running, local scrapbookers will gather for a 12-hour scrapbooking marathon tomorrow (Saturday, April 22) to raise money for Cancer Assistance Services of Halton Hills (CAS-hh).

Crop for Cancer, hosted by the Scrapbook Studio in Georgetown, has donated more than \$30,700 to CAS-hh to date. Organizers hope this year's event at Knox Church will surpass their 2005 total of \$15,200.

The sold-out crop will host 48 participants who have each gathered pledges in advance. From 9 a.m. to 9 p.m., croppers will scrapbook their own family memories, participate in games and enjoy make and take projects.



**PROPOSAL** - The Town of Caledon is preparing an amendment to its Comprehensive Zoning By-law to implement its Official Plan Environmental and Open Space policies. These Official Plan policies were fully approved by the Ontario Municipal Board in 2003 and the preparation of the implementing zoning by-law amendment has been underway since early 2004. Related to this proposed Environmental and Open Space Zoning By-law Amendment, the Town of Caledon is preparing two amendments to its Official Plan and an additional zoning by-law amendment, as listed above.

### PURPOSE AND EFFECT OF THE PROPOSED APPLICATION

**RZ 04-19:** The purpose of proposed rezoning RZ 04-19, the Environmental and Open Space Zoning By-law Amendment, is to amend the Comprehensive Zoning By-law for the Town of Caledon in order to bring it into conformity with the Town's approved Environmental and Open Space Official Plan policies. These Official Plan policies were fully approved by the Ontario Municipal Board in 2003. The effect of the by-law amendment will be to rezone certain lands to place them in a separate "EPA" or "OS" zone category in the by-law and establish by-law provisions that are consistent with the environmental and open space policies of the Official Plan. The amendment will also result in certain lands that have been identified as not meeting the EPA or OS zone criteria, being rezoned to an appropriate zone category.

**POPA 06-01:** The purpose of proposed Official Plan Amendment 206 is to amend the Land Use Schedules to the Caledon Official Plan by deleting and redesignating major areas of Environmental Policy Area. As a result of a mapping review that was undertaken during the preparation of the proposed Environmental and Open Space Zoning By-law Amendment (RZ 04-19), it has been determined that certain lands currently designated Environmental Policy Area in the Caledon Official Plan do not meet the criteria for Environmental Policy Area designation. In order to ensure that the Official Plan land use designations are as accurate as possible and that the Official Plan and the Comprehensive Zoning By-law are based on consistent mapping, this amendment will delete these identified areas from the Environmental Policy Area designation and redesignate them to an appropriate designation.

**POPA 06-02:** The purpose of proposed Official Plan Amendment 207 is to amend the Land Use Schedules to the Caledon Official Plan by adding certain lands to the Environmental Policy Area designation and making related textual changes to the policies of the Official Plan. Lands to be added to Environmental Policy Area are those woodlands that meet the definition of Region of Peel "Core Woodlands" (defined in the Region of Peel Official Plan as woodlands that are a minimum of 30 hectares in size) and that are currently identified on Schedule A of the Region of Peel Official Plan as "Core Areas of the Greenlands System in Peel" but are not currently designated Environmental Policy Area in the Caledon Official Plan. The effect of this proposal will be to bring the Town of Caledon Official Plan into conformity with the "Core Woodlands" policies of the Region of Peel Official Plan.

**RZ 06-03:** The purpose of proposed rezoning RZ 06-03 is to amend the Town of Caledon Comprehensive Zoning By-law to rezone lands that are redesigned to EPA through proposed Official Plan Amendment 207 and place them in an appropriate "EPA" zone category. The effect of this proposal will be to bring the Town of Caledon Comprehensive Zoning By-law into conformity with proposed Official Plan Amendment 207 and the "Core Woodlands" policies of the Region of Peel Official Plan.

Information regarding these proposals has been presented at two previous public Open Houses, June 20, 2005 and March 27, 2006. ### ADDITIONAL INFORMATION

If a person or public body that files an appeal of a decision of the Town of Caledon in respect of the proposed Official Plan and Zoning By-law Amendment applications does not make oral submissions at the public meeting, or make written submissions to the Town of Caledon before the adoption of the proposed Amendments, the Ontario Municipal Board may dismiss all or part of the appeal. Written submissions may be mailed or hand delivered to the Planning and Development Department at 6311 Old Church Road, Caledon, Ontario L7C 1J6.

If you wish to be notified of the approval of the proposed Zoning By-law Amendment applications and the proposed Official Plan Amendment applications, you must make a written request to the Town of Caledon, Planning & Development Department, at the above-noted address.

Copies of the proposed Official Plan Amendments will be available to the public for inspection 20 days prior to the meeting, in the Planning and Development Department during normal office hours. Information regarding the proposed Zoning By-law Amendments will be available to the public for inspection 20 days prior to the meeting. Copies of the proposed Zoning By-law Amendments will be available prior to the meeting. Copies of the proposed Amendments and related information will be posted on the Town of Caledon Website prior to the meeting.

Only individuals, corporations or public bodies may appeal decisions in respect of a Proposed Official Plan Amendment and Zoning By-law Amendment application to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.
